THE Queen has been pleased to appoint Colonel Edward Stopford Claremont, C.B., to be one of the Grooms of the Privy Chamber in Ordinary to Her Majesty, in the room of Samuel Randall, Esq., deceased.

The Queen has been pleased to approve of Don Jorge Zammit y Romero as Vice-Consul at Cardiff, and of Don José Antonio de Lavalle as Vice-Consul at Malta, for Her Majesty the Queen of Spain.

The Queen has been pleased to grant unto John Henry Philipps, of Williamston, in the county of Pembroke, Esquire, Her Majesty's Lieutenant and Custos Rotulorum of the town and county of the town of Haverfordwest, and representative in Parliament for Haverfordwest, only son of Owen Philipps, late of Williamston aforesaid, Esquire, Colonel of the Pembrokeshire Militia, by Elizabeth Anne, his wife, daughter of Henry Scourfield, late of the Mote and Robeston Hall, in the said county of Pembroke, Esquire, and sister of William Henry Scourfield, late of the Mote aforesaid, Esquire, sometime representative in Parliament for Haverfordwest, all deceased, Her Royal licence and authority that he and his issue may, in compliance with a proviso contained in the last will and testament of his maternal uncle the said William Henry Scourfield, take and henceforth use the surname of Scourfield only, and in lieu of that of Philipps, and that he and they may bear the arms of Scourfield quarterly with his and their own family arms, such arms being first duly exemplified according to the laws of arms and recorded in the Herald's Office, otherwise the said Royal licence and permission to be void and of none effect :

And to command that the said Royal concession and declaration be registered in Her Majesty's College of Arms.
