LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF ACT BY THE DISTRICT OF CHORLEY, IN THE COUNTY OF CHESTER.

WHEREAS the Local Government Act, 1858, was duly adopted on the 8th day of September, 1862, by the district of Chorley, in the county of Chester; and notice of such adoption has been duly given, in writing, to me, as one of Her Majesty's Principal Secretaries of State, as required by such Act; and whereas it has now been duly certified to me that a copy of such notice has been advertised for three successive weeks in the Manchester Guardian and the

Manchester Examiner and Times, being two of the local newspapers published and circulated in the said district, and that copies of such notice have also been affixed to the principal doors of each church and chapel in such district to which notices are usually affixed, and the period of twenty-one days fixed by the said Act for appeal against the resolution for the adoption of the said Act by such district has now expired, and no such appeal has been made:

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State, do hereby give notice, that the Local Government Act, 1858, has been duly adopted within the said district of Chorley, in the county of Chester; and that, in accordance with the provisions thereof, the said Act will, at the expiration of two months from the date of the passing of the aforesaid resolution, have the force of law within such district.

THE Secretary of State for India in Council hereby gives notice,—

That, until further notice, sealed Tenders will be received at the Chief Cashier's Office, at the Bank of England, up to two o'clock on the first and third Wednesdays in each month, commencing with Wednesday, the 5th day of November, for Bills of Exchange, payable on demand, to be drawn on the several Governments in India, at Calcutta, Madras, or Bombay, for the sum of Rupees 50,00,000 in each month, of which not more than Rupees 12,00,000 will be drawn on the Government of Bombay, and Rupees 3,00,000 on that of Madras.

Tenders will not be accepted for more than Rupees 30,00,000, on the first Wednesday in each month, and power is reserved to issue Bills for any smaller amount than Rupees 50,00,000 in any one month, and to carry over the difference to the succeeding months.

No Tender is to be for a sum less than Rupees 10,000, and one-eighth of a penny per Rupee is to be the smallest fraction tendered.

Each Tender must specify the rate of Exchange at which the applicant is prepared to purchase a Bill, or any number of Bills, and the lowest amount of any one Bill is to be Rupees 5,000.

The Secretary of State will not be bound to accept any Tender, and reserves the right of accepting the whole or any portion of a Tender.

In the event of two or more Tenders being equal, and the amount remaining to be allotted not being sufficient to supply both or all, the Bank will be instructed to allot rateably.

On the day following the receipt of the Tenders at the Bank, the parties will, on application at the Chief Cashier's Office, be informed whether their Tenders have or have not been accepted.

If accepted, the amount of payment must be lodged at the Bank on or before the 15th and 29th days of each month respectively.

Those applicants whose Tenders shall have been accepted, will be furnished with a Form to be filled up with the particulars of the Bills required, and the Bills themselves, drawn in Duplicate, will be delivered on the day following the payment.
