oTICE is hereby given, that application is intended to be made to Parliament in the ensuing session for an Act to alter, amend, extend, and enlarge all or some of the powers and provisions of an Act of Parliament passed in the first year of the reign of His Majesty King William the Fourth, chapter 38, entitled "An Act for more effectually repairing and improving the road from the Leicester and Welford Road, near Foston-lane, to the road leading from Hinckley to Ashby-de-la-Zouch, and for repairing Hunts-lane and Wood-lane, in the parishes of Desford and Newbold, in the county of Leicester," or to repeal the said Act wholly or in part, and to continue and extend the term granted by the said Act, or to renew or grant a further term, and to make further provisions with reference to the said road.

To make all necessary arrangements for paying off, compounding, and otherwise dealing with the existing mortgage debts, and charges upon the said road, and tolls, and the interest thereon, and for reducing and altering the rate of such interest, and extinguishing arrears thereof, and for fixing the rate of interest to be hereafter paid in respect of such debts, or the proportion of tolls, rates, or duties to be applied in payment of interest and principal, and otherwise varying the rights of the creditors on the said road and tolls, and for altering the application of the income arising therefrom.

And notice is hereby further given, that printed copies of the said intended Act will, on or before the 23rd day of December next, be deposited in the Private Bill Office of the House of Commons.
