Railway Company, on and from the Great Northern Railway, and the railways, sidings, works, warehouses, booking-offices, and conveniences belonging to them, of all traffic of whatever description, coming from or destined for the railways of the Company.

To make provision for the user by the Company, and all persons and companies lawfully using their railways, with their engines and carriages of every description, and with their clerks, officers, and servants, of so much of the Hull and Selby line of the North Eastern Railway Company as is situate between the point of junction of the first-mentioned intended railway, on the west side of the Staddlethorpe station and Hull, and all the railways belonging to the North Eastern Bailway Company, in the parishes of Hessle, North Ferriby, and Kirk-Ella, in the East Riding of the county of York; and also all the railways belonging to them in the town and county of the town of Kingston-upon-Hull, including the railway to the Victoria or East Dock at Hull, and the railways, tramways, and works in which the North Eastern Railway Company and the Dock Company at Kingston-upon-Hull are jointly or severally interested, together with the stations, watering-places, water, bookingoffices, warehouses, sidings, engine sheds, works, and conveniences connected with the said railways, and portions of railway, or any of them, and for the receiving, through-booking, forwarding, and accommodating by the North Eastern Railway Company, on and from the before-mentioned railways and portions of railway, and at and from the stations, warehouses, and booking-offices thereon, or connected therewith, of all traffic of whatever description coming from or destined for the railways of the Company.

And the said intended Act will either specify the terms and conditions, tolls, rates, charges, or other payments, whether annual or in gross, or otherwise, upon and in consideration of which the Company, the South Yorkshire Railway Company, the Great Northern Railway Company, and the North Eastern Railway Company, and all other persons and companies aforesaid respectively, shall be empowered to exercise the powers of user so proposed to be conferred upon them respectively by the said intended Act, and upon and in consideration of which they respectively shall receive, book through, forward, accommodate, and deliver traffic on, at, or from their respective undertakings as before mentioned, or will provide that the same respectively, or some of them, shall be fixed and determined by agreement between those Companies respectively, or shall be settled and determined by arbitration or otherwise, and will enable the said respective Companies to enter into and carry into effect agreements with relation to such respective purposes.

And the said intended Act will provide for the admission, if and when authorised by Parliament, of the South Yorkshire Railway Company, the Great Northern Railway Company, and the North Eastern Railway Company, or any or either of them, as joint owners with the Company of the intended railways and works, or some of them, or some part thereof, or for the acquisition by those three Companies, or any or either of them, of rights, powers, and privileges, in or over the same.

And notice is hereby further given, that before the 30th day of November, in the present year, a published map and plans and sections, describing the lines and levels of the proposed railways and works, together with a book of reference to such No. 22684. F

plans, and a copy of this notice as published in the London Gazette, will be deposited for public inspection with the Clerk of the Peace for the West Biding of the county of York, at his office, in Wakefield, and with the Clerk of the Peace for the East Biding of the county of York, at his office, in Beverley; and that before the said 30th day of November, a copy of so much of such plans, sections, and book of reference as relates to each of the parishes, or extra-parochial places, in or through which the said intended railways and works are proposed to be made; and also a copy of this notice as published in the London Gazette, will be deposited with the parish clerk of each such parish at his place of abode; and, as regards any extra-parochial place, with the clerk of some parish immediately adjoining thereto.
