THE Queen has been pleased to order a Congé d'Elire to pass the Great Seal of the United Kingdom of Great Britain and Ireland, empowering the Dean and Chapter of the Cathedral and Metropolitical Church of York to elect an Archbishop of that See, the same being void by the translation of the Most Reverend Father in God Doctor Charles Thomas Longley, late Archbishop thereof, to the Cathedral and Metropolitical Church of Canterbury; and Her Majesty has also been pleased to recommend to the said dean and chapter the Right Reverend Father in God Doctor William Thomson, now Bishop of Gloucester and Bristol, to be by them elected Archbishop of the said See of York.

Board of Trade, Whitehall, December 4, 1862.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Notice issued by the Portuguese Board of Health declaring the Port of Rio de Janeiro to be considered suspected of infection with yellow fever and with cholera, since the 25th October last.

THE Right Honourable the Lords of the Committee of Privy Council for Trade have received from the Secretary of State for Foreign Affairs copies of Despatches from Her Majesty's Consul in Honduras, enclosing copies of Laws recently passed by the Government of that Republic regulating, as follows, the payment of import and tonnage duties:

The existing import duty of 20 per cent. ad valorem on all articles except liquors is replaced by one on all articles, including liquors, of 6 per cent. ad valorem, payable in cash, to which is added 20 per cent. ad valorem, payable in Government Bonds (the latter at the present market price representing only 34 per cent. in cash.)

Every merchant vessel which anchors in the northern ports of the Republic shall pay one real (6d.) for every ton measurement up to 400 tons, above which each ton will be charged at one
