The Queen has been pleased to appoint Charles Royes, Esq., to be a Member of the Legislative Council of the Island of Jamaica.

The Queen has been pleased to grant unto Frederic-James Aldrich, Clerk, Bachelor of Arts, Curate of Chingford, in the county of Essex, and to Louisa Blake Aldrich his wife, daughter of William Morison, of Aberdeen, in North Britain, deceased, by Elizabeth his wife, sister of Thomas Blake, formerly of the colony of British Guiana, and late of Loudoun-road, St. John's-wood, in the county of Middlesex, Esquire, also deceased, Her Royal Licence and authority, that they and their issue may, in compliance with a proviso contained in the last will and testament of the said Thomas Blake, the maternal uncle of the said Louisa Blake Aldrich, take and henceforth use the surname of Blake in addition to and after that of Aldrich :
