to a boundary stone, inscribed 'P. Q. St. J. C. C., 1862, No. 2, and placed on the southern side of the said road upon the boundary dividing the township of Tirymenech, in the said parish of Guilsfield, from the township of Varchoel, in the same parish; and extending thence, first southeastward, to such boundary stone, and then south-westward, along the said township boundary as far as a point in the middle of the road leading from Guilsfield to Coppice; and extending thence, first south-eastward, then south-westward, and then again south-eastward, along the middle of the last-described road to its junction with the road leading from 'The Bank' to Coppice aforesaid; and extending thence, southward, along the middle of the last described road to its southern extremity, and continuing thence in a straight line, and in the last-mentioned direction, to the boundary dividing the said parish of Guilsfield from the parish of Pool, otherwise called Welshpool aforesaid, at the northern angle of the plantation, numbered 936 upon the tithe commutation map of the last named parish, and upon the map hereunto annexed; and extending thence, south-westward, along the last-mentioned parish boundary, as far as a point in the middle of a certain road leading past Rallt to Welshpool; and extending thence, first southward and then south-westward, along the middle of the last-described road as far as a point opposite to the middle of the north-western end of the fence dividing the close numbered 909 upon .the before-mentioned maps from the close numbered 906 upon the same maps; and extending thence, south-eastward, to and along the middle of such fence, and along the middle of the fence dividing the closes numbered respectively 908 and 914 upon the said maps, from the close, numbered 907 upon the same maps, to the junction of the last-mentioned fence with the fence dividing the said close, numbered 914, from the close numbered 915 upon the aforesaid maps; and extending thence, southward, along the middle of the last-described fence, to its junction with the fence dividing the close numbered 780 upon the said maps, from the said close, numbered 915, from the plantation numbered 916, and from the close and premises numbered 724 upon the same maps; and extending thence, south-eastward, along the middle of the lastdescribed fence, to a point in the middle of a certain road leading to the towing-path of the Shropshire Union Canal aforesaid, opposite to the middle of the south-eastern extremity of the said fence; and extending thence, still south-eastward, along the middle of the last-described road, crossing the said canal to a point in the middle of the said towing-path; and extending thence, southwestward, along the middle of the said towingpath, as far as a point opposite to the middle of the north-western end of the fence dividing the close, numbered 728 upon the said maps, from the close numbered 729 upon the same maps; and extending thence, south-eastward, to and along the middle of the said fence to a point in the middle of the road leading from Welshpool to Pool Quay, opposite to the middle of the southeastern extremity of the same fence; and extending thence, north-eastward, along the middle of the last-described road, for a distance of 240 yards, or thereabouts, to a point opposite to a boundary stone inscribed 'P. Q. St. J. C. C. 1862, No. 3, and placed on the eastern side of the said road, at a point where the said road abuts upon the River Severn; and extending thence, eastward, to such boundary stone, and continuing thence in the same direction to the boundary in the middle of the said River Severn, which divides the parish

of Pool, otherwise called Welshpool aforesaid, from the parish of Buttington, in the county and diocese aforesaid."

Her Majesty having taken the said representation, together with the map thereunto annexed, into consideration, was pleased by and with the advice of Her Privy Council to approve thereof; and to order, and it is hereby ordered, that the consolidated chapelry therein mentioned for the consecrated church of Saint John the Evangelist, situate at Pool Quay, in the parish of Guilsfield, in the county of Montgomery, be accordingly formed; and that the agreement mentioned in the said representation, with respect to the right of presentation and appointment of an incumbent or perpetual curate to serve the said church, be carried into effect, agreeably to the provisions of the said Acts; and that the said right of presentation and appointment of an incumbent or perpetual curate to serve the said church, shall belong to, and be exercised by, the Right Honourable Edward James, Earl of Powis, his heirs and assigns for ever: and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Saint Asaph.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; duly prepared and laid before Her Majesty in Council a representation, bearing date the eleventh day of December, in the year one thousand eight hundred and sixty-two, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nine-teenth and twentieth years of your Majesty, chapter fifty-five; have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Anne, situate at Bowden Hill, in the parish of Lacock, in the county of Wilts, and in the diocese of Gloucester and Bristol.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Anne, situate at Bowden Hill aforesaid.

"Now, therefore, with the consent of the Right Reverend William, Bishop of Gloucester and Bristol, testified by his having signed and sealed this representation, we humbly represent, that it would, in our opinion, be expedient that all that part of the said parish of Lacock, described in the schedule hereunto annexed, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto also annexed, should be assigned to the said church,
