

parish of Ellel, and of the said parish of Saint Helen, Garstang, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Mark, situate at Dolphinholme aforesaid.

"Now, therefore, with the consents of the Right Reverend James Prince, Bishop of Manchester (the bishop of the diocese); of the Reverend Richard Atkinson, the vicar or incumbent of the vicarage of the parish of Cockerham, in the said county of Lancaster, and, as such vicar or incumbent, the patron of the perpetual curacy of the said new parish of Ellel; and of Thomas Pedder, of Finsthwaite, in the parish of Colton, in the said county of Lancaster, Esquire; and of Richard Pedder, of Winckley-square, in the parish of Preston, in the said county of Lancaster, Esquire, the patrons of the vicarage of the said parish of Saint Helen, Garstang (in testimony whereof they have respectively signed and sealed this representation), we humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Ellel, and of the said parish of Saint Helen, Garstang, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Mark, situate at Dolphinholme aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Mark, Dolphinholme.'

"And we further represent that it has been mutually agreed between the said Richard Atkinson, Thomas Pedder, and Richard Pedder (testified as aforesaid), that the right of presentation and appointment to the church of the said consolidated chapelry of Saint Mark, Dolphinholme, shall belong to, and be exercised by, Henry Garnett, of Wyreside, in the said county of Lancaster, Esquire, his heirs and assigns, for ever.

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order in respect thereto as to your Majesty in your Royal wisdom shall seem meet."

The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Mark, Dolphinholme, being:—

"All that portion of the new parish of Ellel, in the county of Lancaster, and in the diocese of Manchester, which is situate to the south-east of an imaginary line extending along the middle of the turnpike-road leading from Caton to Cockerham, and also all that portion of the parish of Saint Helen, Garstang, in the same county and diocese, which is situate to the north-east of an imaginary line commencing upon the boundary dividing such parish from the new parish of Ellel aforesaid, at a point in the middle of the road leading from Galgate to Chipping, and extending thence south-eastward along the middle of such road (crossing Street Bridge, and also the road leading from Scorton to Bracken Hill, and passing over Harrisend Fell) to the boundary at Grizedale Brook which divides the township of Nether Wyersdale, in the said parish of Saint Helen, Garstang, from the township of Barnacre-with-Bonds, in the same parish, and extending thence, first north-eastward along such boundary, and then southward, along the same boundary, to the boundary dividing the said parish of Saint Helen, Garstang, from the parish of Lancaster, in the county and diocese aforesaid."

Her Majesty having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof; and to order, and it is hereby ordered, that the consolidated chapelry therein mentioned for the consecrated church of Saint Mark, situate at Dolphinholme, in the new parish of Ellel, in the county of Lancaster, be accordingly formed; and that the agreement mentioned in the said representation with respect to the right of presentation and appointment of an incumbent or perpetual curate to serve the said church, be carried into effect, agreeably to the provisions of the said Acts; and that the said right of presentation and appointment of an incumbent or perpetual curate to serve the said church, shall belong to and be exercised by Henry Garnett, of Wyreside, in the said county of Lancaster, Esquire, his heirs and assigns for ever; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Manchester.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Town Council of the borough of NEWCASTLE-UNDER-LYME, in the county of STAFFORD, have under the provisions of an Act, passed in the session of Parliament held in the seventeenth and eighteenth years of Her Majesty's reign, intituled "An Act to make further provision for the burial of the dead in England, beyond the limits of the metropolis," presented a petition to Her Majesty in Council, stating that certain Orders in Council have been issued directing that burials be discontinued, in the churchyard of St. John's Church, Hauley, in the parish of Stoke-upon-Trent; and with certain modifications, in the churchyards of St. Giles's and St. George's, both in the parish of Newcastle-under-Lyme; and representing that there is difficulty and inconvenience in providing the requisite and sufficient places of burial for the inhabitants of the said parishes of Stoke-upon-Trent and Newcastle-under-Lyme, under the powers and provisions of the Act, passed in the session of Parliament held in the sixteenth and seventeenth years of Her Majesty's reign, intituled "An Act to amend the Laws concerning the burial of the dead in England beyond the limits of the metropolis," and to amend the Act concerning the "burial of the dead in the metropolis"; and praying that powers may be vested in the said Town Council for providing such place or places of burial under the provisions of the various Acts of Parliament relating to burials as shall be deemed requisite for the inhabitants of the said parishes of Stoke-upon-Trent, and Newcastle-under-Lyme.

Now, therefore, Her Majesty in Council is pleased hereby to give NOTICE of such petition, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the twenty-third day of March next:

And Her Majesty is further pleased to direct that this Order be published in the London Gazette, and in one of the newspapers usually circulating in the borough of NEWCASTLE-UNDER-LYME, one month at least before the said twenty-third day of March.
