LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF PARTS OF ACT BY FENTON, STAFFORDSHIRE.

WHEREAS certain portions of the Local Government Act, 1858, were on Tuesday, the 1st day of March, 1859, duly adopted by the Commissioners of Police of the Fenton District, acting in such district, under the powers of the Act 2nd Vict. cap. 44. And whereas the aforesaid Commissioners, on Tuesday, the 7th day of February, 1860, duly adopted a further portion of the hereinbefore recited Local Government Act, 1858. Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, do hereby give notice, that the said fourth and fifth sections of the Local Government Act, 1858, have been duly adopted within the district of Fenton, under the jurisdiction of the Commissioners aforesaid, and that, in accordance with the provisions of such Act, the hereinbefore recited fourth and fifth sections of the Local Government Act, 1858, will, from the date of the passing of the aforesaid resolution of the 3rd day of February, 1863, adopting the said sections of such Act, have the force of law within such district of Fenton.
