NOTICE OF ADOPTION OF PARTS OF ACT BY BRIGHOUSE, WEST RIDING OF YORKSHIRE.

WHEREAS on the 17th day of April, 1863, the Commissioners for carrying into execution an Act passed in the ninth year of the reign of Her present Majesty (9 and 10 Vict., cap. 385), intitled "An Act for sewerage, draining, and lighting the hamlet of Brighouse, in the township of Hipperholme-cum-Brighouse, in the parish of Halifax, in the West Riding of the county of York," duly convened and acting under the provisions of such Act, adopted certain portions of the Local Government Act, 1858, that is to say, sections 34, 35, 45, 50, 57, and 77; and also a portion of the Public Health Act, 1848, that is to say, section 49. And whereas, notice of the adoption of the hereinbefore recited sections of the Local Government Act, 1858, and Public Health Act, 1848, has been duly given in writing, to me, as one of Her Majesty's Principal Secretaries of State.

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, do hereby give notice, that the hereinbefore recited sections of the Local Government Act, 1858, and Public Health Act, 1848, have been duly adopted by the said Commissioners of the aforesaid hamlet of Brighouse, acting under the provisions of the hereinbefore recited Act (9 and 10 Vict., cap. 385), and that in accordance with the provisions of the Local Government Act, 1858, the hereinbefore recited sections of the said Local Government and Public Health Acts will, from and after the passing of the aforesaid resolution adopting the hereinbefore recited sections of such Acts, have the force of law within the hamlet of Brighouse aforesaid.
