This day the Lords being met a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for granting to Her. Majesty certain duties of Inland Revenue; and to amend the laws relating to the Inland Revenue.

An Act to defray the charge of the Pay, Clothing, and contingent and other expenses of the disembodied Militia in Great Britain and Ireland; to grant allowances in certain cases to

Subaltern Officers, Adjutants, Paymasters, Quartermasters, Surgeons, Assistant Surgeons, and Surgeon's Mates of the Militia; and to authorize the employment of the Non-commissioned Officers.

An Act for carrying into effect the Report of the Commissioners appointed to inquire into the State of the dioceses of Canterbury, London, Winchester, and Rochester; and for other purposes.

An Act for the prevention and punishment of offences committed by Her Majesty's subjects in South Africa.

An Act to carry into effect an additional Article to the Treaty of the seventh day of April, one thousand eight hundred and sixty-two, between Her Majesty and the United States of America, for the suppression of the African Slave Trade.

An Act to amend the Act for placing the employment of women, young persons, and children in Bleaching Works and Dyeing Works under the regulations of the Factories Acts.

An Act to confirm certain Provisional Orders under the Local Government Act (1858) relating to the districts of Basford, Teignmouth, Kingstonupon-Hull, Nottingham, Bradford, Ryde, Bedford, Croydon, Batley, Berwick-upon-Tweed, Sheerness, and Bromsgrove.

An Act to authorise the Mayor, Aldermen, and Citizens of the city of Coventry, in the county of Warwick, to erect a Market-house in the said city.

An Act for making better provision for the management and relief of the Poor in the city of Norwich, and county of the same city.

An Act for incorporating the Skipton Gas Light and Coke Company, and for conferring upon them further powers for the supply of gas to the township of Skipton, and certain neighbouring townships in the West Riding of the county of York.
