Sussex.

AT the General Quarter Session of the Peace of our Lady the Queen, holden at Lewes, in and for the county of Sussex, on Monday, the 19th day of October, in the 27th year of the reign of our Sovereign Lady Victoria, by the Grace of God of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith, and in the year of our Lord 1863, before the Right Honorable Henry Thomas, Earl of Chichester, George Darby, Esq., the Right Honorable Charles Lord Colchester, and others their Fellows, Justices of our said Lady the Queen, assigned to keep the Peace in the said county, and also to hear and determine divers felonies, trespasses, and other ill deeds done and committed in the county aforesaid.

"Whereas at a Court of General Quarter Session of the Peace, holden at Lewes, in and for the county of Sussex, on the 29th day of June last, it was Provisionally ordered (under the Statute 25th and 26th Victoria, chapter 61, 'For the better management of the Highways in England,') that the parishes undermentioned, in the Eastern division of the said county should be formed into highway districts for the purposes of the 'Highway Acts,' namely, the parishes of Alciston, Barcombe, Beddingham, Berwick, Bishopstone, Blatchington, Chailey, Chalvington, Chiltington, Denton, Ditchelling, East Aldrington, Falmer, Fulking, Glynde, Hamsey, Hangleton, Heighton, Iford, Kingston, Newhaven, Newick, Newtimber, Ovingdean, Patcham, Piddinghoe, Piecombe, Plumpton, Portslade, Poynings, Preston, Ringmer, Ripe, Rodmell, Rottingdean, St. John the Baptist, Southover, Seaford with Sutton-cum-Seaford, Selmeston, South-east, Southmalling, Stanmer, Street, Tarring-Neville, Telscombe, West Blatchington, Westfirle, and Westmeston, and such parts respectively of the parishes of Hove, St. John-under-the-Castle, Lewes, and St. Peter and St. Mary Westout, Lewes; the highways whereof are not maintained under the provisions of any local Act or Acts of Parliament, into a district to be called the 'Lewes Highway District.'

"The parishes of Ardingly, Balcombe, Bolney, Clayton, Crawley, Horsted, Keynes, Hurstperpoint, Keymer, Slaugham, Twineham, and Wivelsfield, and such parts respectively of the parishes of Cuckfield and Lindfield, as do not constitute districts

under the Public Health Act, 1848, the Local Government Act, 1858, or either of them, into a district to be called the 'Cuckfield Highway District.'

"The parishes of Alfriston, Arlington, Chidingly, Eastdean, Friston, Folkington, Hailsham, Heathfield, Hellingly, Herstmonceux, Jevington, Jaughton, Lillington, Lullington, Pevensy, Warbleton, Wartling, Westdean, Westham, Willingdon, and Wilmington, into a district to be called the 'Hailsham Highway District.'

"The parishes of Buxted, Easthoathly, Fletching, Framfield, Isfield, Littlehorsted, Maresfield, and Waldron, into a district to be called the 'Uckfield Highway District.'

"The parishes of East Grinstead, Hartfield, Westhoathly, Withyham, and Worth, into a district to be called the 'East Grinstead Highway District.'

"The parishes of Mayfield, Rotherfield, and Wadhurst, and such part of the parish of Frant as is not within the limits of the Tunbridge Wells Local Act, into a district, to be called the 'Mark Cross Highway District.'

"The parishes of Ashburnham, Beckley, Brede, Brightling, Catsfield, Crowhurst, Dallington, East Guildesford, Ewhurst, Fairlight, Guestling, Hollington, Hooe, Icklesham, Iden, Mountfield, Ninfield, Northiam, Peasmarsh, Penhurst, Pett, Playden, St. Thomas the Apostle Winchelsea, Sedlescomb, Udimore, Westfield, and Whatlington, and such parts of the parishes of Ore, St. Mary-in-the-Castle, St. Leonard, and St. Mary Bulverhithe, as are not within the limits of the borough of Hastings, and such part of the parish of Rye as is not within the limits of the borough of Rye, into a district to be called the 'Hastings Highway District.'

"The parishes of Bodiam, Burwash, Etoehingham, Salehurst, and Ticehurst, into a district to be called the 'Burwash Highway District.'

"And that the number of Waywardens which each parish and part of a parish in the said Lewes, Cuckfield, Hailsham, and Hastings Highway Districts should elect should be as follows:—Namely, each parish and part of a parish in the said last-mentioned Districts should elect one Waywarden. And the number of Waywardens which each parish and part of a parish in the said Uckfield, East Grinstead, Mark Cross, and Burwash Highway Districts should elect should be as follows:—Namely, each parish and part of a parish in the said last-mentioned Districts should elect two Waywardens."

And whereas the Justices assembled at the said last-mentioned Quarter Session did appoint this present General Quarter Session of the Peace for the taking into consideration the confirmation of the above-recited Provisional Order, by a Final Order.

And whereas such Provisional Order has been duly published in the London Gazette, and in two newspapers circulating in the said Eastern division of the said county, and a copy of such Order has been sent by post in a prepaid letter to the Churchwardens or Overseers of every parish in the said several proposed Highway Districts, and there was added to the notice of the said Provisional Order a notice that the confirmation of the said Provisional Order, by a Final Order, would be taken into consideration by the Justices at this present Session.

And whereas the Clerk of the Peace for the county aforesaid did send with the notice required by law to be given of the holding of Courts of General Quarter Session, a notice in the form marked B in the schedule of the said Act, or as near thereto as circumstances admit, that the confirmation of the said Provisional Order, by a Final
