ORDER REGULATING THE USE OF LOCOMOTIVES ON THE ROADS OF THE ARRINGTON TRUST, IN THE COUNTY OF CAMBBIDGE.

WHEREAS it appears to me, the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, that the use of Locomotives, unless restricted as hereinafter mentioned, on or along the road from Cambridge to the Old North Road near Arrington Bridge, in the county of Cambridge, and highways adjacent thereto, is dangerous and inconvenient to the public :

I do hereby, by virtue of the provisions of "The Locomotive Act, 1861," by this order under my hand, prohibit the use of any kind of Locomotive whatever propelled by steam or any other than animal power on the above road and highways, except between the hours of twelve o'clock at night and six o'clock in the morning.
