The light will be a fixed white light, placed at

an elevation of 34 feet above the mean level of the sea, and should be seen in clear weather from a distance of 9 miles.

lenses, of the sixth order.

The tower is hexagonal, 21 feet high, of lead colour, with a white lantern. It stands 55 yards from the extremity of the mole, in lat. 28° 28' 30" N., long. 16° 14' 56" west of Greenwich. There is also a red light on the mole head.
