NOTICE OF ADOPTION OF ACT BY OPENSHAW, LANCASHIRE.

WHEREAS the Local Government Act, 1858, was, on the 19th day of November, 1863, adopted by the township of Openshaw, in the parish of Manchester, in the county of Lancaster; and notice of such adoption has been duly given, and the other requirements of the said Act have been complied with:

NOTICE OF ADOPTION OF PARTS OF ACT BY NEWTON IN MACKERFIELD, LANCASHIRE.

WHEREAS certain portions of the Local Government Act, 1858, were, on Monday, the 16th day of November, 1863, duly adopted by the Newton in Mackerfield Improvement Commissioners, acting under the Act of 18 and 19 Vict., cap. 100, entitled "An Act for the Improvement of the town of Newton in Mackerfield and neighbourhood, in the county of Lancaster,"—such portions so adopted being sections 57 and 78 of the aforesaid Local Government Act, 1858; and whereas notice of the adoption of the said hereinbefore mentioned sections of such Act, has been given, in writing, to me, as one of Her Majesty's Principal Secretaries of State.
