or in any part or parts thereof, in such manner as shall appear to us advisable.

"Now, therefore, we humbly recommend and propose that we may be authorised and empowered by instrument or instruments in writing, duly executed according to law, from time to time to sell or dispose of and duly to convey, according to the provisions of the said Act of the sixth and seventh years of your Majesty's reign, all or any of the said lands, tenements, hereditaments, and endowments, theretofore belonging to the said prebend of Freeford, and so vested in us as aforesaid, with their appurtenances, and all our estate, right, title, and interest therein, or in any part or parts thereof unto and to the use of any person or persons desirous or willing to purchase the same, and his, her, or their heirs, executors, administrators, or assigns, or otherwise, as he, she, or they, shall direct or appoint, and for such consideration, as shall, upon due calculation and inquiry, appear to us to be just and reasonable.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council : now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Lichfield.

WW HEREAS by an Act, passed in the session of Parliament, held in the eighteenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the "laws concerning the burial of the dead in "England," it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time, to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit ;

And whereas certain Orders in Council have been made, directing the discontinuance of burials in the churchyard and burial-grounds hereinafter mentioned, from the time specified in such Orders respectively; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyard and burial-grounds, be postponed;

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyard and burialgrounds, be postponed, as follows; viz.:

- In the churchyard of CUMBERWORTH, Yorkshire, from the first of January to the first of April, one thousand eight hundred and sixtyfour.
- In the burial-grounds of the Wesleyan and Baptist Chapels, Haddenham, to the thirtyfirst of May, one thousand eight hundred and sixty-four.

HEREAS the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, after giving to the Incumbent and the Churchwardens of the parishes hereinafter mentioned, ten days' previous notice of his intention to make such representation, has, under the provisions of an Act, passed in the session of Parliament, held in the sixteenth and seventeenth years of Her Majesty's reign, initialed "An Act to amend the laws con-"cerning the burial of the dead in England "beyond the limits of the metropolis, and to " amend the Act concerning the burial of the dead " in the metropolis," made a representation stating that, for the protection of the public health, interments should be discontinued, in the undermentioned parishes, with the following modifications; viz. :

- BROADWATER.—Forthwith-entirely within four feet of the boundary wall on the north side of the churchyard; and in the new part of the churchyard with the exception of now existing vaults and brick graves which can be opened without disturbing soil that has already been buried in ;—each coffin to be embedded in a layer of powdered charcoal four inches thick, and separately entombed in brick or stonework, cemented in an airtight manner; —and also with the exception of existing reserved earthen grave spaces, which can be opened without disturbing human remains, in which no body shall be buried without a covering of four and a half feet of earth.
- BIRMINGHAM.—Forthwith in All Saints' Churchyard, except in now existing vaults and walled graves, and in already purchased private graves, to be used in accordance with the regulations for new burial-grounds.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the nineteenth day of January next:

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of or on some conspicuous places within the parishes affected by such representation, one month before the said nineteenth day of January.
