WHEREAS by an Act, passed in the session of Parliament, held in the eighteenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the "laws concerning the burial of the dead in "England," it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time, to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit ;

And whereas certain Orders in Council have been made, directing the discontinuance of burials in the churchyards hereinafter mentioned, from the time specified in such Orders respectively; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyards, be postponed;

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards, be postponed, as follows ; viz. :

- In the churchyard of DALSTON, from the thirtyfirst of December, one thousand eight hundred and sixty-three, to the twenty-eighth of February, one thousand eight hundred and sixty-four.
- In the churchyard of GILDERSOME, from the thirty-first of December, one thousand eight hundred and sixty-three, to the thirtieth of June, one thousand eight hundred and sixtyfour.
- In the churchyard of NEWENT, from the thirtyfirst of December, one thousand eight hundred and sixty-three, to the thirty-first of March, one thousand eight hundred and sixty-four.
- In the churchyard of PETERSHAM, from the first of January, one thousand eight hundred and sixty-four, to the thirty-first of December, one thousand eight hundred and sixty-five, provided that no new grave be dug in ground which has been already buried in.

WHEREAS by an Act, passed in the Session of Parliament, held in the twentieth and twenty-first years of Her Majesty's reign, intituled "An Act to amend the Burial Acts," it is, amongst other things, enacted that it shall be lawful for Her Majesty, upon the representation of one of Her Majesty's Principal Secretaries of State, by and with the advice of Her Privy Council, from

such other persons as may have the cars of any vaults or places of burial, for preventing them from becoming or continuing dangerous or injurious to the public health; and that every such Order in Council shall be published in the London Gazette, and that such churchwardens or other rersons shall do or cause to be done all acts ordered as aforesaid, and the expenses incurred in and about the doing thereof shall be paid out of the poor rates of the parish : provided always, that no such representation shall be made until ten days' previous notice of the intention to make such representation shall have been given to the churchwardens or other persons, or one of the churchwardens, or other persons having the care of the vaults or places of burial to which the representation relates ;

And whereas the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, after ten days' previous notice of his intention to make such representation having been duly given to the churchwardens or other persons having the care of the vaults and graves in the undermentioned churches and chapels, has made a representation, stating that he is of opinion that, for the purpose of preventing the said vaults and graves from becoming injurious to the public health, an Order should be made for the adoption of the measures which are hereinafter set forth ;

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that the churchwardens or such other persons as may have the care of the said vaults and graves in the undermentioned churches and chapels do adopt, or cause to be adopted, the following measures, viz. :-

That the coffins now uncovered in the vaults beneath THE PARISH CHURCH, TRINITY CHURCH, ST. JOHN'S WOOD EPISCOPAL CHAPEL, BLANDFORD - STREET BAPTIST CHAPEL, and GROVE-ROAD ROMAN CATHOLIC CHAPEL, all in the parish of St. Marylebone, be embedded in soil mixed with charcoal and enclosed by concrete or by masonry, or brickwork properly cemented, and that such disinfectants be used, or other precautions taken for the safety of the men employed in the work, as the Officer of Health for the district of St. Marylebone shall direct.
