"Whereas it has been made to appear to us that it would promote the interests of religion, that the particular part of the said parish of Saint Pancras hereinafter mentioned and described should be constituted a separate district, in the manner hereinafter set forth.

"And whereas certain hereditaments and premises situate within the said parish of Saint Pancras have become vested in us, under the provisions of and for the purposes of the herein-

mentioned Acts.

"Now, therefore, with the consent of the Right Honourable and Right Reverend Archibald Campbell, Bishop of London, (in testimony whereof he has signed and sealed this scheme), we humbly recommend and propose that all that part of the said parish of Saint Pancras, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme, become and be constituted a separate district for spiritual purposes, and that the same shall be named 'The District of Saint James,

Hampstead Road.'

"And we further recommend and propose that there shall be paid by us, in each and every year, by equal half-yearly payments, on the first day of May and the first day of November, to the minister for the time being of the district so recommended to be constituted, when duly licensed in accordance with the provisions of the herein secondly mentioned Act, the sum of one hundred and fifty pounds, and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or the first day of November next after the day of the date of the licence of such minister as aforesaid; and that in case a vacancy in the ministry of such district shall happen on any other day than the first day of May or the first day of November, the amount next thereafter payable shall be duly apportioned between and paid to the minister making the vacancy, or his personal representative or representatives, and the minister succeeding to such district: Provided always, that if it shall appear to us to be expedient at any future time that instead of the annual sum then in course of payment by us to the minister of the said district, or instead of any part of such annual sum, any land tithe or other hereditament should be conveyed or secured to such minister and his successors in fee, nothing herein or in any other scheme contained shall prevent us from recommending and proposing such a substitution.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of

Parliament.

The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint James, Hampstead Road, being:-

"All that part of the parish of Saint Pancras, in the county of Middlesex, and in the diocese of London, wherein the present incumbent of such parish now possesses the exclusive cure of souls, which is comprised within and is bounded by an imaginary line commencing upon the boundary dividing the said parish from the new parish of Christehurch, Saint Pancras, in the same county

and diocese, at a point in the middle of Stanhope Street opposite to the middle of the south-western end of Rutland Street, and extending thence southward along the said boundary following the middle of Stanhope Street aforesaid and the middle of Mary Street, to the junction of the same boundary in the middle of the last-named street with the boundary dividing the said parish of Saint Pancras from the new parish of Saint Mary Magdalene, Saint Pancras, in the county and diocese aforesaid, and continuing thence still southward along the last-described boundary (still following the middle of Mary Street aforesaid) as far as a point opposite to the middle of the south-western end of Charles Street, and extending thence northeastward to and along the middle of the last-named street to its junction with the Hampstead Road, and extending thence south-eastward along the middle of the said road to a point on the boundary dividing the said parish of Saint Pancras from the new parish of All Saints, Saint Pancras, in the same county and diocese, such point being situate at the junction of the said Hampstead Road with the Euston Road, and extending thence northeastward along the last-described boundary (following the middle of the last-named road) as far as the point where such road is intersected by the road forming the western side of Euston Square, and extending thence north-westward along the middle of the last-described road to its junction with Melton Street, and continuing thence still north-westward along the middle of the lastnamed street to its junction with Drummond Street, and extending thence north-eastward along the middle of the last-named street as far as a point on the boundary dividing the said parish of Saint Pancras from the district chapelry of Somers Town, in the county and diocese aforesaid, such point being opposite to the middle of the south-eastern end of Whittlebury Street, and extending thence first north-westward along the last-described boundary following the middle of the last-named street, and then westward along the same boundary following the middle of Cardington Street as far as the point at which such boundary diverges from the last-named street, and extending thence first northward and then north-westward along the same boundary to its junction in the middle of the road forming the north-western side of Ampthill Square with the boundary dividing the said parish of Saint Pancras from the new parish of Saint Matthew, Bedford New Town, in the county and diocese aforesaid, and extending thence first southwestward along the last-described boundary following the middle of the last-mentioned road, and then northward along the same boundary following the middle of the Hampstead Road aforesaid, and then south-westward still along the same boundary following the middle of Rutland Street aforesaid to the junction of such boundary with the boundary dividing the parish of Saint Pancras from the new parish of Christchurch, Saint Pancras, as aforesaid, at the first-described point in the middle of Stanhope Street opposite to the middle of the south-western end of Rutland Street aforesaid, where the said imaginary line commenced-

"Save and except such portion of the territory situate within the limits hereinbefore described as consists of a certain plot of land comprising four acres, or thereabouts, which said plot has been, under the provisions of certain Acts of Parliament, to wit, those of the twenty-ninth George the Third, chapter forty-seventh, and of the thirtieth George the Third, chapter seventy, taken for the purposes therein specified out of the said parish of Saint Pancras and made for such purposes a patr of the parish of Saint James, Westminster."
