Flashing Light.

BLACK ROCK, COUNTY MAYO, NORTH-WEST COAST OF IRELAND.

THE Port of Dublin Corporation hereby give notice, that a Lighthouse has been erected on the Black Rock, near the entrance to Black Sod Bay, from which a light will be exhibited on the night of the 1st of June, 1864, and continued every night thereafter, from sunset to sunrise, the position and characteristics of which, as specified by their Inspector of Lights, are as follows:—

The lighthouse is erected on the western extremity of the Black Rock, near the entrance to Black Sod Bay, county Mayo, in latitude 54° 4' 10" north, and longitude 10° 19' 20" west. The tower is circular, of a dark stone colour, and its height from base to top of dome is 50 feet.

The light will be exhibited from a first order dioptric apparatus, at an elevation of 263 feet above high water, spring tides, and will show a flash every half minute, bright to seaward, and red towards the land, between the bearings of N.E. by E., ¼ E., round eastward to S.E. by E., and will be seen in clear weather about 22 nautical miles.

Bearings are magnetic, variation 27° 45' west.
