"At the General Quarter Session of the Peace, holden at Saint Mary, Newington, in and for the county of Surrey, on Tuesday, the 5th day of January, 1864:—

"Whereas at the General Quarter Session of the Peace, holden at Kingston-upon-Thames, in and for the county of Surrey, on Tuesday, the 20th day of October, 1863, a Provisional Order was duly made, under the authority of the Act 25 and 26 Vict., cap. 61, dividing the whole of the said county, except those portions thereof which are under the Metropolis Local Management Act, or within the Kingston Highway District, and except certain other parishes and places, into the Highway Districts hereafter named, for the more convenient management of the highways therein, that is to say:—

"The Chertsey Highway District—consisting of the following parishes and places in the said county, which separately maintain their own highways: Bisley, Byfleet, Chobham, Egham, Horsell, Pyrford, Thorpe, Weybridge, and Windlesham.

"The Croydon Highway District—consisting of the following parishes and places in the said county, which separately maintain their own highways: Addington, Beddington, Carshalton, Coulsdon, Mitcham, Morden, Sanderstead, Wallington, and Woodmansterne.

"The Dorking Highway District—consisting of the following parishes and places in the said county, which separately maintain their own highways: Abinger, Bookham Great, Bookham Little, Capel, Effingham, Mickleham, Newdigate hamlet and parish, Ockley, and Wootton.

"The Epsom Highway District—consisting of the following parishes and places in the said county, which separately maintain their own highways: Ashted, Banstead, Cheam, Chessington, Cuddington, Ewell, Fetcham, Headley, Leatherhead, Sutton, and Walton-on-the-Hill.

"The Farnham Highway District—consisting of the following parishes and places in the said county, which separately maintain their own highways: Ash and Normandy (not including Frimley), Elstead, Frensham, Frimley, Seale and Tongham, and Waverley.
