of the said lanc as far as a point opposite to the middle of the south-eastern end of a certain private road leading through the farm-yard belonging to the messuage or homestead known as Lower Chisbury Farm and connecting Chisbury-lane aforesaid with Monk's-lane, and extending thence north-westward to and along the middle of the said private road to its junction with Monk's-lane, and continuing thence, either north-westward or north-eastward, along the middle of the lastnamed lane as far as a point opposite to a boundary stone inscribed '7. S. F. St. K. C. C. 1863,' and placed on the northern side of the said last-named lane at the point where the boundary which formerly divided the plantation called Herring Point Coppice and numbered 166 upon a certain map called the Little Bedwyn map and deposited in the said estate office, and upon the map hereunto annexed, from the close called Lower Cow Leys and Upper Wood Furlong, and numbered 145 upon the said two last-mentioned maps, commenced and extending thence north-westward to such boundary stone, and continuing thence northwestward along the line of the said old boundary as far as the point where such old boundary meets the fence which actually divides the said lastnamed plantation from the said last-named close, and continuing theuce in a direction generally north-westward along the middle of the last described fence, and of the fence which divides the same last-named close from the plantation called Wood Furlong Coppice, and numbered 165 upon the said two last-mentioned maps to a point in the middle of a certain occupation road leading past and forming the eastern boundary of the wood called Round Coppice and numbered 164 upon the said two last-mentioned maps, such point being opposite to the middle of the northern extremity of the last-described fence; and extending thence north-eastward along the middle of the lastmentioned occupation road as far as a point opposite to the middle of the south-eastern end of the fence which forms the northern boundary of Round Coppice aforesaid; and extending thence north-westward to and along the middle of the last-described fence to a point in the middle of the road leading from Horse Hall Hill to the Hungerford and Marlborongh turnpike-road, opposite to a boundary stone inscribed 'S. S. F. St. K. C. C. 1863,' and placed in the middle (or nearly so) of the northern end of the said last-described fence and extending thence north-eastward along the middle of the said road leading from Horse Hall Hill to the junction of the same road with the aforesaid turnpike-road leading from Hungerford to Marlborough, and continuing thence in a direct line still north-eastward across such turnpike-road to a point on the boundary dividing the said parish of Little Bedwyn from the parish of Froxfield, in the same county and diocese, and extending thence in a direction generally north-westward along the last-described parish boundary to its junction with the boundary dividing the said parish of Little Bedwyn from the parish of Ramsbury, in the same county and diocese, and extending thence in a direction mainly south-westward or westward along the last-described parish boundary to its junction with the boundary dividing the said parish of Little Bedwyn from the parish of Mildenhall, in the same county and diocese; and extending thence first southward and then generally south-westward along the last-described parish boundary to its junction with the boundary dividing the said parish of Little Bedwyn from the new parish of Savernake, in the same county and diocese, and extending thence in a direction generally south-eastward along the last-described parish boundary to its junction with the boundary dividing the said parish of Burbage from the said

new parish of Savernake, and extending thence south-westward along the last-described parish boundary as far as a point in the middle of the northern end of the fence forming the western boundary of the several closes numbered respectively 687, 688, and 686, upon the tithe commutation map of the said parish of Burbage, and upon the map hereunto annexed, such point being near to a boundary stone inscribed '9. S. F. St. K. C. C. 1863,' and placed in the most western angle of the close numbered 687 as aforesaid, and extending thence southward along the middle of the last-described fence to a point in the middle of the road, known as the Green Drive, otherwise 'Love Walk,' opposite to the ' Love middle of the southern extremity of the said lust-described fence, and extending thence south-eastward along the middle of the said lastmentioned road (crossing the road leading from Burbage to Durley) to a point in the middle of the fence forming part of the southern boundary of Savernake Forest aforesaid, and extending thence first southward and then south-eastward along the middle of the said fence to the point opposite to the boundary stone numbered 1, where the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by aud with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Salisbury.

the words and figures following; that is to say: "We, the Ecclesinstical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint John the Evangelist, situate in the parish of Saint Andrew, Greenstead, in the county of Essex, and in the diocese of Rochester.

"Whereas at certain extremities of the parishes of Saint Andrew, Greenstead aforesaid, of Saint Michael, Mile End, otherwise Myland, of Langham, of Ardleigh, of All Saints, Colchester, and of Saint Botolph, Colchester, all in the said county and diocese, which lie contiguous one to another.
