(No. 15.) - MEDITERRANEAN-ISLAND OF CYPRUS.

Red Light on Cape Kiti.

THE Turkish Government has given notice, that on and after the 15th day of March, 1864, a light would be exhibited from a lighthouse recently erected at Cape Kiti, on the south side of the island of Cyprus.

The light is a fixed red light, placed at an elevation of 92 feet above the mean level of the sea, and should be seen in clear weather at a distance

of 6 miles.

The tower stands about 90 yards from the extremity of the cape, at 6 miles southward of
