sex, Clerk, the patrons of the perpetual curacy of the parish of Clifton aforesaid, and of the perpetual curacy of the said district chapelry of Saint Paul, Clifton; and with the consents of the Reverend John Hensman, the incumbent of the perpetual curacy of the said parish of Clifton; and of the Reverend Frederick Vaughan Mather, the incumbent of the perpetual curacy of the said district chapelry of Saint Paul, Clifton (testified by their having respectively signed and sealed this representation), we humbly represent that, in our opinion, it would be expedient that the boundaries of the said district chapelry of Saint Paul, Clifton, should be altered, so as to dissever from the said parish of Clifton, and to include within the said district chapelry, all that further portion of the said parish of Clifton, which is described in the schedule hereunder written, and is delineated and set forth on the map hereunto annexed; and that the said lastmentioned portion of the said parish of Clifton shall, upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council, ratifying this representation, be so included within, and shall be and form part of the said district chapelry of St. Paul,

"And we humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto, as to your Majesty in your Royal wisdom, shall seem meet."

The SCHEDULE to which the foregoing Representation has reference.

"Territory proposed to be dissevered from the parish of Clifton and annexed to the district chapelry of Saint Paul, Clifton:—

"All that portion of the parish of Clifton, in the county of Gloucester, and in the diocese of Gloucester and Bristol, which is comprised within and is bounded by an imaginary line, commencing at the point in the middle of Queen's-road, where the boundary of the parish of Saint Michael, Bristol, in the county and diocese aforesaid, is met by the boundary which divides the said parish of Clifton from the district chapelry of Saint Paul, Clifton (sometime part of the said parish of Clifton), and extending thence north-westward along the last-described boundary, fol-lowing in part the middle of the said Queen's road, and in part the middle of the road called Richmond-hill, as far as a point in the middle of Queen's-road aforesaid, opposite to the middle of the north-western end of the said Richmondhill; and extending thence south-westward along the middle of the said Queen's-road for a distance of fifty yards or thereabouts, to a point opposite to the middle of the north-western end of the wall which divides the garden and premises belonging to Waterloo Villa, from the garden and premises belonging to the house known as No. 2, Park House, and numbered and named accordingly on the map hereunto annexed, and from the garden and premises belonging to the house known as No. 1, Park House, and numbered and named accordingly on the said map hereunto annexed; and extending thence south-eastward to and along the middle of the said wall to its southern extremity; and extending thence in a direct line north-eastward diagonally across the road called 'Richmond Spring Road, to a point in the middle of the north-western end of the wall which divides the garden and premises belonging to Devonshire Villa from the garden and premises belonging to Coburg Villa, and from the garden and premises belonging to Clifton Villa; and extending thence

south-eastward along the middle of the last described wall to its south-eastern extremity, and continuing thence still south-eastward to and along the middle of the road known as Frederick Place, to its junction with the road known as Meridian Place; and extending thence north-eastward along the middle of the last-named road to its junction with the road called Ruysdale Place; and extending thence south-eastward along the middle of the last-named road, passing the front of the Roman Catholic Chapel to the junction of the said last-named road with the road known as Park Place, and continuing thence still south-eastward to the middle of the north-western end of a certain passage which leads from Park Place aforesaid past the Convent of Saint Catherine, towards Berkeley Place; and extending thence still south-eastward along the middle of such passage as far as a point opposite to the easternmost angle of the wall which encloses the premises belonging to the said convent; and extending thence first south-westward, to and along the middle of the said wall, then north-westward, and then north-eastward along the middle of the same wall, as far as a point opposite to the middle of the south-eastern extremity of a certain embankment called Honeypen-hill Embankment, which passes along the back of Berkeley Court and Rock Court; and extending thence first north-westward to and along the middle of the said embankment, and then south-westward along the middle of the same embankment to its extremity; and extending thence south-eastward to a point in the middle of the wall dividing the gardens belonging to the houses on the western side of Rock Court aforesaid, from the houses and gardens on the eastern side of Burton's Court; and extending thence first southward, and then south-eastward along the middle of the said wall to a point in the middle of a certain passage which connects Burton's Court with Rock Court aforesaid, opposite to the middle of the south-eastern end of the said wall; and extending thence north-eastward along the middle of the said passage to its junction with Rock Court; and extending thence south-eastward along the middle of the last-named Court to a point on the boundary dividing the said parish of Clifton from the parish of Saint George, Bristol, in the county and diocese aforesaid, such point being situate on the northern side of Berkeley Place aforesaid, opposite to the middle of the south-eastern end of Rock Court; and extending thence north-eastward along the last-described boundary to its junction near the south-western end of the road called the Triangle, with the boundary which divides the said parish of Clifton from the parish of Saint Michael, Bristol, aforesaid; and continuing thence still north-eastward along the last-described boundary to the point in the middle of the Queen's Road, where the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the respective Registrars of the said diocese of Gloucester and Bristol, at Bristol and at Gloucester.
