

BLACK SEA.*Revolving Light on Soukhoum Point.*

Information has been received at the Admiralty that a *revolving* light is exhibited from a lighthouse recently erected on Soukhoum point, near Soukhoum Kaleh, coast of Circassia. The point is low, and the tower 102 feet high, but no other particulars have been received.
