LOCAL GOVERNMENT ACT, 1858.

ILKESTON, DERBYSHIRE.

WHEREAS an appeal has been duly presented to me, as one of Her Majesty's Principal Secretaries of State, under the Local Government Act, 1858, signed by owners and ratepayers of the hamlet of Little Hallam, in the parish of Ilkeston, in the county of Derby, praying for its exclusion from the operation of the said Act; and whereas inquiry has been directed and made into the circumstances of the case, and into the matters alleged in such appeal, as required by such Act, and report has been made to me thereon.

Now, therefore, I do hereby order—

That the aforesaid appeal be dismissed, and that the Local Government Act, 1858, shall, from and after the 20th day of June instant, have the force of law within the aforesaid parish of Ilkeston, in the county of Derby.

LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF ACT BY RAVENSTHORPE, YORKSHIRE.

WHEREAS the Local Government Act, 1858, was adopted by the district of Ravensthorpe, in the West Riding of the county of York, as settled for the purposes of such Act, on the 21st day of April, 1864; and notice of such adoption has been duly given, and the other requirements of the Act have been complied with:

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State, do hereby give notice, that the Local Government Act, 1858, has been adopted in the hereinbefore-named district of Ravensthorpe; and that, although it is a place with a population of less than 3000 by the last census, it is expedient, by reason of special circumstances, that it should be allowed to adopt the said Act; I do, therefore, hereby approve of such adoption by the aforesaid district of Ravensthorpe, and order that such Act do come into force within that district from and after the 21st day of June, 1864.
