## PRESENT,

The QUEEN's MostExcellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-first day of April, in the year one thousand eight hundred and sixty-four, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of the Holy Trinity, situate at Little Amwell, in the parish of All Saints, Hertford, in the county of Hertford, and in the diocese of Rochester.

"Whereas at certain extremities of the said parish of All Saints, Hertford, and of the parish of Saint John, Hertford, thereto annexed, and of the parish of Great Amwell, in the county and diocese aforesaid, which lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such respective parishes.

"And whereas it appears to us to be expedient, that such contiguous portions of the said parishes of All Saints, Hertford, Saint John, Hertford, and Great Amwell, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of the Holy Trinity, situate at Little Amwell aforesaid.

"Now, therefore, with the consents of the Right Reverend Joseph Cotton, Bishop of the said diocese of Rochester, of the Right Honorable Richard, Baron Westbury, Lord High Chancellor of Great Britain, acting on behalf of your Majesty, as the alternate patron in right of the Crown of the vicarage of the said parish of All Saints, Hertford, and of the rectory of the said parish of Saint John, Hertford, thereto annexed, of the Most Honorable John Villiers Stuart, Marquis Townshend, the alternate patron with the Crown of the vicarage and rectory lastly mentioned, of Harriet McNab, of Ware, in the said county of Hertford, Widow, of Daniel Robert McNab, of Epping, in the county of Essex, Surgeon, of Joseph Thomas Humphry, of Princes-square, Bayswater, in the county of Middlesex, Barristerat-Law, and of George Murray Humphry, of the town of Cambridge, Doctor of Medicine, the trustees of the will of the late William NcNab, Esquire, deceased, and as such trustees the patrons in trust of the vicarage of the said parish of Great Amwell, and of Harriet Parrott (the wife of the Reverend Richard Parrott, of Great Amwell aforesaid, Clerk), being the person entitled under the same will to nominate to the trustees for the time being of such will a vicar or incumbent to hold the vicarage of the said parish of Great Amwell (in testimony of which several consents the said parties hereinbefore named have respectively signed and sealed this representation), we humbly repre-

sent, that it would, in our opinion, be expedient that all those contiguous portions of the said parish of All Saints, Hertford, of the said parish of Saint John, Hertford, and of the said parish of Great Amwell, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of the Holy Trinity, situate at Little Amwell aforesaid, and that the same should be named 'The Consolidated Chapelry of the Holy Trinity, Little Amwell.'

"And we furthur represent, that it has been proposed, with the like consents of the said Richard, Baron Westbury (acting on behalf of your Ma-jesty as aforesaid), John Villiers Stuart, Marquis Townshend, Harriet McNab, Daniel Robert McNab, Joseph Thomas Humphry, George Murray Humphry, and Harriet Parrott (so testified as aforesaid), and it would, in our opinion, be expedient that the right of presentation and appointment to the church of the said consolidated chapelry of the Holy Trinity, Little Amwell, should belong to and be exercised jointly by the Honorable and Reverend Lowther Barrington, the rector or incumbent of the rectory of the parish of Watton, in the said county of Hertford, by the Reverend Charles Deedes, the vicar or incumbent of the vicarage of the parish of Bengeo, in the said county of Hertford, by the Reverend Thomas Woodward, the vicar or incumbent of the vicarage of the parish of Thundridge, in the said county of Hertford, and by Robert Cooper Lee Bevan, of Trent Park, in the said county of Middlesex, Esquire, their heirs and assigns.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

## The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of the Holy Trinity, Little Amwell, being :--

"All those several portions of the liberty of Little Amwell, within the parish of All Saints, Hertford, in the county of Hertford, and in the diocese of Rochester, of the parish of Great Amwell, in the same county and diocese, and of the parish of Saint John, Hertford, also in the same county and diocese, which are comprised within and bounded by an imaginary line, commencing upon the boundary dividing the said liberty of Little Amwell from the parish of Great Amwell aforesaid, at a point in the middle of the road called Walnut Tree Walk; and extending thence first southward and then alternately southeastward and south-westward along the said boundary, as far as a point in the middle of the road leading from Little Amwell to Amwell ; and extending thence south-westward as far as a point upon the boundary dividing the said parish of Great Amwell, from the parish of Saint Margaret, Stanstead, in the same county and diocese, such point being situate at the north-west angle of such boundary, and being also situate at or near to the eastern side of a certain footpath leading from Little Amwell aforesaid to Hailey Bury; and extending thence south-eastward along the last-named boundary, following also mainly the course of the said footpath as far as the point at which the same boundary diverges to the east, at or near to the northeastern corner of a certain occupation road leading
