

chapelry for the said church of All Saints, situate at Rhodes aforesaid, and that the same should be named 'The Consolidated Chapelry of Rhodes.'

"And we further represent that it has been proposed, with the like consents of the said William Wagstaff and Thomas, Earl of Wilton (so testified as aforesaid), and it would in our opinion be expedient that the right of presentation and appointment to the church of the said consolidated chapelry of Rhodes, should belong to and be exercised by the rector or incumbent for the time being of the said parish of Middleton.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Rhodes being:—

"All that portion of the parish of Middleton, in the county of Lancaster, and in the diocese of Manchester, and also all that portion of the parish of Prestwich, in the same county and diocese, which are bounded on the north by the consolidated chapelry district of Saint Mary, Birch, in the said county and diocese; on the east by the new parish of the Holy Trinity, Parkfield, in Middleton, in the same county and diocese; on the south by the new parishes of Tonge-cum-Alkington, and of Saint Peter, Blackley, both in the county and diocese aforesaid; and on the west by an imaginary line commencing upon the boundary dividing the said parish of Middleton from the consolidated chapelry district of Saint Mary, Birch aforesaid, at a point near Bow Lee, upon the eastern side of the Manchester and Heywood Trust-road, such point being situate at a distance of seventy-five yards or thereabouts to the north of the milestone indicating five and a half miles from Manchester; and extending thence first westward in a direct line to a point in the middle of the said Trust-road, and thence south-eastward along the middle of the same road, to its junction with the Rochdale and Manchester Trust-road; and extending thence north-eastward along the middle of the last-named Trust-road, for a distance of one hundred and fifty-four yards or thereabouts, to a point opposite to the middle of the north-western end of a certain occupation road leading to Lands End Bleach Works; and extending thence south-eastward to and along the middle of such occupation road to its south-eastern termination; and continuing thence in a direct line still south-eastward to and across the River Irk, to the boundary on the southern bank of the same river, which divides the said parish of Prestwich from the new parish of Saint Peter, Blackley aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; duly prepared and laid before Her Majesty in Council a representation, bearing date the second day of June, in the year one thousand eight hundred and sixty-four, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; have prepared, and now humbly lay before your Majesty in Council the following representation for altering the boundaries of the consolidated chapelry or new parish of Hounslow, in the county of Middlesex, and in the diocese of London.

"Whereas by the authority of an Order in Council of His late Majesty King William the Fourth, bearing date the twenty-second day of December, in the year one thousand eight hundred and thirty-five, and published in the London Gazette upon the sixteenth day of February in the following year, certain contiguous portions of the parish of Heston, in the county and diocese aforesaid, and of the parish of Isleworth, in the same county and diocese, were formed into a consolidated chapelry, and were assigned to a consecrated church, situate at Hounslow, in the said parish of Heston, and such consolidated chapelry was called 'The Consolidated Chapelry of Hounslow.'

"And whereas the said consolidated chapelry of Hounslow is reputed to have become, under the provisions of the Act of the nineteenth and twentieth years of your Majesty, chapter one hundred and four, a new parish of the character contemplated by the Act of the sixth and seventh years of your Majesty, chapter thirty-seven.

"And whereas it has been proposed to us, and it has been made to appear to us to be expedient that the boundaries of the said consolidated chapelry or new parish of Hounslow, should be altered in the manner hereinafter described.

"Now, therefore, with the consents of The Right Honorable and Right Reverend Archibald Campbell, the Bishop of the said diocese of London, and the Patron in right of his See, both of the vicarage of the said parish of Heston, and of the perpetual curacy of the said consolidated chapelry or new parish of Hounslow, of the Reverend Edward Spooner, the Vicar or Incumbent of the vicarage of the said parish of Heston, of the Reverend Edward East, the Incumbent of the perpetual curacy of the said consolidated chapelry or new parish of Hounslow, and of the Reverend Henry William Perry Richards, the Vicar or Incumbent of the vicarage of the said parish of Isleworth (in testimony whereof they have respectively signed and sealed this representation), and with the consent of the Dean and Canons of the Queen's Free Chapel of Saint George within her Castle of Windsor, the Patrons of the vicarage of the
