"And, with the like consent of the said Charles Thomas, Archbishop of Canterbury (testified as aforesaid), we further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials, should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that so long as the Reverend Henry Francis Sidebottom, the present rector or incumbent of the rectory of the said parish of Sevenoaks shall continue to be such rector or incumbent, all the said fees shall be paid by the minister aforesaid to the said Henry Francis Sidebottom.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Riverhead, being:—

"All that part of the parish of Sevenoaks, in the county of Kent and in the diocese of Canterbury, which is situate to the west of an imaginary line commencing upon the boundary dividing such parish from the parish of Otford, in the same county and diocese, at a point in the middle of the turnpike-road leading from Dartford to Sevenoaks; and extending thence south-eastward along the middle of the said road as far as the centre of the bridge which carries such road over the line of the Sevenoaks Railway Extension to Tub's Hill; and extending thence south-westward along the middle of the said line of railway as far as a point near Tub's Hill, under the centre of the bridge which carries the road leading from Sevenoaks to Riverhead over the same line of railway; and extending thence north-westward along the middle of the last described road to its junction with a certain other road leading from Riverhead past Britton's Farm and past the house called the Cross Keys towards Sevenoaks Common; and extending thence, mainly southward, along the middle of the last described road to its intersection at or near to the said house called the Cross Keys, by the road leading from Sevenoaks towards Bailey's-hill; and extending thence south-westward along the middle of the last described road to the boundary which divides the said parish of Sevenoaks from the new parish of Sevenoaks Weald, in the county and diocese aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Canterbury.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; duly prepared and laid before Her Majesty in Council a representation, bearing date the seventh day of July, in the year one thousand eight hundred and sixty-four, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; have prepared, and now humbly lay before your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint Nicholas, situate in the parish of Plumstead, in the county of Kent, and in the diocese of London.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Nicholas, situate in the parish of Plumstead aforesaid.

"Now, therefore, with the consent of the Right Honorable and Right Reverend Archibald Campbell, Bishop of the said diocese of London (testified by his having signed and sealed this representation), we humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Plumstead, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned to the said church, and that the same should be named 'The District Chapelry of Saint Nicholas, Plumstead.'

"And, with the like consent of the said Archibald Campbell, Bishop of the said diocese of London (testified as aforesaid), we further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials, should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns, and of the solemnization or performance of the said offices, should be paid and belong to the minister of the same church for the time being: Provided always, that so long as the Reverend James Adair McAllister, the present vicar or incumbent of the vicarage of the said parish of Plumstead, shall continue to be such vicar or incumbent, all the fees which shall be payable in respect of the performance of the said offices at the said church of Saint Nicholas, shall be paid by the minister thereof to the said James Adair McAllister.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.
