**LOCAL GOVERNMENT ACT, 1858.**

**NOTICE OF ADOPTION OF ACT BY THE DISTRICT OF ST. AUSTELL, CORNWALL.**

WHEREAS the Local Government Act, 1858, was, on the 29th day of September, 1864, duly adopted by the district of St. Austell, in the county of Cornwall, within the boundaries of that district, as settled for the purposes of the hereinbefore recited Act, and notice of such adoption has been duly given, in writing, to me, as one of Her Majesty's Principal Secretaries of State, as required by such Act: And whereas it has now been duly certified to me that a copy of such notice
