

NAVAL PRIZE MONEY.

*Department of the Accountant-General
of the Navy, Admiralty, Somerset-

NOTICE is hereby given to all persons interested therein, that preparations are now being made for the intended distribution of the slave and tonnage bounties, &c., of three dhows, names unknown, captured by Her Majesty's ship "Rapid," on the 9th April, 25th April, and 2nd December, 1863, respectively.
