Light Vessel off Wicklow Head.

The light will be a *fixed red* light, at an elevation of 39 feet above the level of the sea, and in clear weather should be visible from a distance of 9 miles.

Alteration of Arklow Bank Light.

Also, that on or about the above date, the Arklow Bank light will be changed from revolving every minute, to once every half minute.

These changes will be made simultaneously with the exhibition of the light from the light vessel off Wicklow Head.
