(No. 25.)—BLACK SEA.

Revolving Light at St. George mouth of the Danube.

THE European Commission of the Danube has given notice, that on and after the 4th day of May, 1865, a light would be exhibited from a lighthouse recently erected at the mouth of the St. George branch of the Danube.

The light is a *revolving* light, attaining its greatest brilliancy every *minute*, showing alternately *red* and *white* faces; the eclipses are total. The light is seen in clear weather from a distance of 10 miles.

The illuminating apparatus is dioptric or by lenses, of the fourth order.

The Tower is of wood, and stands on the small sandy islet at the south end of Olinka island, in lat. 44° 51' 5" N., long 29° 36' 52" East of Greenwich.
