NOTICE TO MARINERS.

(No. 30.)-North Atlantic-Canary Islands. Revolving Light on Delgada Point, Alegranza Island.

THE Minister of Marine at Madrid has given notice, that on and after the 30th day of July, 1865, a light will be exhibited from a lighthouse recently erected on Delgada point, on the east side of Alegranza, one of the Canary Islands.

The light will be a revolving white light, attaining its greatest brilliancy every half minute, and seen through an arc of 270°, or when bearing from about S.S.E. ¹/₄ E. round by west and north to N.E. by E. ³/₄ E. It is placed at an elevation of 57 feet above the mean level of the sea, and in clear weather should be visible from a distance of 13 miles.

The illuminating apparatus is dioptric or by lenses, of the fourth order.

The tower is slightly conical, 49 feet high, dark gray, with a green lantern, and stands at about 240 yards within the extremity of the point, in lat. 29° 23' 48" N., long. 13° 29' 36" West of Greenwich.

Red Light on Martino Point, Lobos Islet.
