A T the Court at Windsor, the 29th day of June, 1865.

PRESENT.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by an Act passed in the Session of Parliament, holden in the sixteenth and seventeenth years of the reign of Her present Majesty, intituled "An Act to amend and con- solidate the laws relating to the Customs of the "United Kingdom, and of the Isle of Man, and certain laws relating to trade and navigation, and the British possessions," it is enacted, that, if "the legislature or proper legislative authority, of any of the British possessions abroad, shall present an address to Her Majesty, praying Her. Majesty to authorise or permit the conveyance of goods or passengers from one part of such possession to another part thereof in other than British ships, it shall thereupon be lawful for Her Majesty, by Order in Council, so to authomise the conveyance of such goods or passengers on such terms, and under such conditions, as to "Her Majesty may seem good:"

And whereas an address has been presented to Her Majesty, by the Legislative Council of St. Lucia, praying Her Majesty to authorize and permit the conveyance of goods and passengers from one part of that island to any other part of the same in other than British ships:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and in virtue of the authority committed to Her by the said recited Act, doth order, and it is hereby ordered, that from and after the day of the date of this Order, goods and passengers may be conveyed from one part of the island of Saint Lucia to another part thereof in other than British ships:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Edward Cardwell, one of Her Majesty's Principal Secretaries of State, are to give the necessary directions herein as to them may respectively appertain.

WHEREAS by an Act passed in the session of Parliament held in the eighteenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the "laws concerning the burial of the dead in "England," it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time, to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit:

And whereas certain Orders in Council have been made, directing the discontinuance of burials in the churchyards and burial grounds hereinafter mentioned, from the time specified in such Orders; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyards and burial-grounds be postponed;

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards and burial-grounds be postponed as follows; viz.:

In the churchyard of the parish of Hessle to the thirtieth of June, one thousand eight hundred and sixty-five.

In the churchyard of the parish of Swanscombe, Kent, to the first of August, one thousand eight hundred and sixty-five.

In Brockenhurst churchyard to the first of November, one thousand eight hundred and sixty-five.

In the churchyard of Cumberworth, Yorkshire, to the first of October, one thousand eight hundred and sixty-five.

In the churchyard, and in the Wesleyan and Independent Burial-grounds, Middlewich, to the seventh of June, one thousand eight hundred and sixty-six, provided that no grave be dug less than four feet deep, nor unless it can be so dug without exposing any coffin.
