The QUEEN's Most Excellent Majesty in Council.

**THEREAS** the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five; duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-third day of March, in the year one thousand eight hundred and sixty-five, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of your Majesty, chapter seventy; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Andrew, situate at Welsh Frankton, in the parish of Whittington, in the county of Salop, and in the diocese of Saint Asaph.

"Whereas at certain extremities of the said parish of Whittington, and of the parish of Ellesmere, in the said county of Salop, and in the diocese of Lichfield, which lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such respective parishes.

"And whereas it appears to us to be expedient that such contiguous portions of the said parish of Whittington, and of the said parish of Ellesmere, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Andrew, situate at Welsh Frankton aforesaid.

"Now, therefore, with the consents of the Right Reverend Thomas Vowler, Bishop of the said diocese of Saint Asaph, of the Right Reverend-John, Bishop of the said diocese of Lichfield. of Louisa Lloyd, of Aston Hall, in the said county of Salop, Widow, the patron of the rectory of the said parish of Whittington, and of the Right Honourable John William Spencer Brownlow Egerton, Earl Brownlow, the patron of the vicarage of the said parish of Ellesmere (in testimony whereof they have respectively signed and scaled this representation), we humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Whittington and of the said parish of Ellesmere, which are described in the schedule hereunder written, all which portions; together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and

church of Saint Andrew, situate at Welsh Frankton aforesaid, and that the same should be named 'The Consolidated Chapelry of Welsh Frankton,' and that the right of presentation and appoint-ment to the church of such consolidated chapelry should belong to and be exercised alternately by the rector or incumbent for the time being of the rectory of the parish of Whittington aforesaid and by the said John William Spencer Brownlow Egerton, Earl Brownlow, his heirs and assigns, and that the first such right should belong to and should be exercised by the said rector.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty, in

your Royal w sdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Welsh Frankton, being: -

"All those several portions of the parish of Whittington, in the county of Salop and in the diocese of Saint Asaph, and of the parish of Ellesmere, in the same county and in the diocese of Lichfield, which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the said parish of Whittington from the parish of Hordley, in the same county and in the said diocese of Lichfield, at a point in the centre of the bridge over the Ellesmere Canal, called 'Lockgate-bridge;' and extending thence, south-westward, along the middle of the said canal for a distance of one hundred and fifty yards or thereabouts, to a point opposite to the middle of the south-eastern end of a certain stream dividing the close numbered 1915b upon the tithe commutation map of the said parish of Whittington, and upon the map hereunto annexed from the close numbered 1920a upon the same maps; and extending thence, first north-westward, to and along the middle of the said stream, and then westward along the middle of the same stream to the boundary dividing the said parish of Ellesmere, from the extra-parochial part or place called or known as Halston, in the said county of Salop; and continuing thence, still westward, along the last described boundary to its junction with the boundary dividing the parish of Whittington from the parish of Ellesmere aforesaid; and extending thence, first north-westward, along the last described boundary (crossing the line of the Oswestry and Ellesmere Railway), and then north-eastward along the same boundary to its junction with the boundary in the middle of a certain lane leading from Lower Ridge to New Marton, which divides a detached portion of the township of Old Marton in the said parish of Whittington, from the township of Hindford, in the same parish; and extending thence, northwestward, along the last-described boundary, following thereby the middle of the said lane to the junction of such boundary with the boundary dividing the parish of Whittington from the parish of Ellesmere as aforesaid; and extending thence, first south-westward, then north-westward, and then north-eastward along the last-mentioned boundary to its junction with the boundary dividing the said parish of Ellesmere from the parish of Saint Martin, in the same county and in the said diocese of Saint Asaph; and continuing thence, still north-eastward, along the lastdescribed boundary to its junction with the boundary dividing the township of New Marton, formed into one consolidated chapelry for the said in the said parish of Ellesmere, from the township
