

and chapelry of Duddlestone, in the same parish ; and extending thence, south-eastward, along the last-described boundary to its junction with the boundary dividing the parish of Whittington from the parish of Ellesmere as aforesaid ; and continuing thence, still south-eastward, along the last-described boundary to a point in the middle of Perthy-lane ; and extending thence north-eastward for a distance of fifty-seven yards, or thereabouts, along the middle of the said lane to a point opposite to the middle of the south-western end of a fence which divides the closes numbered respectively 13, 12, and 11 upon the tithe commutation map of the said parish of Ellesmere, and upon the map hereunto annexed, from the closes numbered respectively 14 and 15 upon the same maps ; and extending thence north-eastward to and along the middle of such fence to its junction with the fence which divides the said close numbered 11 from the close numbered 8 upon the said maps ; and extending thence southward along the middle of the last-described fence to its southern end on the northern side of Perthy-lane aforesaid ; and continuing thence, first southward to the middle of the said lane, and then south-eastward along the middle of the same lane, as far as a point under the centre of the bridge which carries over such lane the line of the Oswestry and Ellesmere Railway aforesaid ; and extending thence north-eastward along the middle of the said line of railway for a distance of three hundred and eighty-four yards, or thereabouts, to a point opposite to the middle of the north-western end of Old Hardwick-lane ; and extending thence south-eastward to and along the middle of the last-named lane to its junction with the Oswestry and Ellesmere turnpike-road ; and extending thence in a direct line due south across the said turnpike-road and across the lands belonging to the farm called ' The Buildings,' to a boundary stone inscribed ' W. F. C. C. 1865,' and placed on the northern side of the road leading from Welsh Frankton to Tetchill ; and continuing thence, still southward, to a point in the middle of the last-described road ; and extending thence eastward along the middle of the same road for a distance of five furlongs, or thereabouts, to a point in the centre of the bridge which carries the said road over the Ellesmere Canal aforesaid ; and extending thence, first south-westward, then south-eastward, and again south-westward, along the middle of the said canal, for a distance of thirteen furlongs, or thereabouts, to a point under the centre of the bridge which carries over such canal the road leading from Wood Farm and Broom Farm to Welsh Frankton ; and extending thence south-westward and in a direct line across the lands belonging to Wood Farm aforesaid, to the point on the boundary which divides the parish of Whittington from the parish of Hordley aforesaid, in the centre of Lockgate Bridge, where the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council : now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts ; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Saint Asaph, and by the Registrar of the said diocese of Lichfield.

The **QUEEN's** Most Excellent Majesty in Council.

**W**HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, and of the Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and twenty-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-second day of June, in the year one thousand eight hundred and sixty-five, in the words and figures following ; that is to say :

" We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter one hundred and thirteen, and of the Act of the twenty-third and twenty-fourth years of your Majesty, chapter one hundred and twenty-four, have prepared, and now humbly lay before your Majesty in Council the following scheme, for making better provision for the cure of souls in certain parishes and districts.

" Whereas the several benefactions, consisting of sums of cash or stock, land, rent-charge, and other hereditaments which are mentioned in the fourth column of the schedule hereunto annexed, have been paid over or transferred to us in favour of, or have been otherwise legally secured to, the several benefices set forth in the first column of the same schedule respectively, upon condition that certain annual sums hereinafter mentioned shall be paid by us out of our common fund, created by the herein firstly-mentioned Act, to the incumbents for the time being of the said several benefices respectively ; and, upon further condition, that in respect of such of the said benefactions as consist of cash or Government stock, or in respect of such part or parts thereof as shall from time to time remain in our hands, there shall be paid by us to the incumbents for the time being of the said benefices respectively, by equal half-yearly payments on the first day of May, and the first day of November in each year, the yearly sums respectively specified and set forth in the fifth column of the same schedule, or a proportionate part of each of such annual sums.

" Now, therefore, we humbly recommend and propose, that we may be authorized and empowered to pay out of the said common fund, by equal half yearly payments on the first day of May and the first day of November in each year, to the incumbent for the time being of each of the several benefices specified in the first column of the said schedule hereunto annexed respectively, the annual sum, the amount of which is set against the name of each such benefice in the sixth column of the same schedule.

" And we further recommend and propose that if at any time it shall appear to us to be desirable that land, tithe, or other hereditaments should be substituted for such, or any of such, annual sums, nothing herein contained shall prevent us from recommending and proposing such a substitution, or from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament.
