

road to Windmill-corner aforesaid; and continuing thence still north-westward and in a direct line across the road leading from Harlow Bush-common towards Matching to the middle of the southern end of the road which leads from Windmill-corner aforesaid to Old House Farm; and extending thence still north-westward along the middle of the last described road as far as a point opposite to a boundary stone inscribed 'H. St. M. M. D. C., 1865, No. 2,' and placed on the western side of the same road on the eastern bank of the ditch which divides Old House Farmstead, numbered 688 upon the said maps from the close numbered 693 upon the same maps; and extending thence westward in a straight line to the said boundary stone, and continuing thence in the same direction to a point in the middle of the said ditch; and extending thence northward along the middle of the same ditch which also divides the closes numbered respectively 689, 690, and 691, upon the said maps, from the closes numbered respectively 693, as aforesaid, and 692, upon the same maps, as far as a point opposite to a boundary stone inscribed 'H. St. M. M. D. C., 1865, No. 3,' and placed on the western bank of the said ditch, at a point in the middle of the south eastern end of the fence dividing the close numbered 565 upon the said maps from the closes numbered respectively 692, as aforesaid, and the wood numbered 696 upon the same maps; and extending thence north-westward to such boundary stone, and continuing thence in the same direction along the middle of the last described fence and along the middle of the fence dividing the close numbered 564 upon the said maps from the wood numbered 696, as aforesaid, and from the close numbered 557 and from the plantation numbered 558 and from the plantation called Upper New Pond Spring and numbered 559 upon the maps aforesaid to a boundary stone inscribed 'H. St. M. M. D. C., 1865, No. 4,' and placed at the northern corner of the last-named plantation at a point on the southern side of the occupation road leading from Arkwright's Gravel Pit to the London-road; and extending thence northward in a straight line to the boundary in the middle of the last described occupation road, which divides the said parish of Saint Mary the Virgin, Harlow, from the new parish of Saint John, Harlow, in the county and diocese aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter

one hundred and thirteen, duly prepared and laid before Her Majesty in Council a scheme, bearing date the fifteenth day of June, in the year one thousand eight hundred and sixty-five, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter one hundred and thirteen, have prepared, and now humbly lay before your Majesty in Council the following scheme, for making better provision for the cure of souls within the parish of Poulton, in the county of Gloucester, and in the diocese of Gloucester and Bristol.

"Whereas the patronage of the church of the said parish is vested in and belongs to Herbert John Marshall, of Poulton aforesaid, Esquire, and he is willing and has agreed to transfer such patronage to the Right Reverend Charles John, Bishop of the said diocese of Gloucester and Bristol, and his successors, Bishops of the same diocese, for ever.

"And whereas with a view to making better provision for the incumbent for the time being of such parish, the said Herbert John Marshall has paid to us the sum of one hundred pounds upon the understanding and faith that we the said commissioners should submit to your Majesty in Council the recommendation with respect to the patronage of the church of the said parish, which is hereinafter accordingly made.

"And whereas we have in respect of the said sum of one hundred pounds agreed and have undertaken to provide and pay by equal half-yearly payments on the first day of May and the first day of November in each and every year, to the incumbent for the time being of the said parish, the sum of three pounds six shillings and eight pence.

"Now, therefore, with the consents of the said Charles John, Bishop of the said diocese of Gloucester and Bristol, and of the said Herbert John Marshall (in testimony whereof they have respectively signed and sealed this scheme), we humbly recommend and propose that the advowson and perpetual right of patronage of, and presentation to, the parish church of the said parish of Poulton, and all the estate, right, title, use, trust, property, claim, and demand therein of the said Herbert John Marshall, shall upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme, and without any conveyance or assurance in the law other than such scheme and duly gazetted Order, be assigned to, and become and be absolutely vested in the said Charles John, Bishop of the said diocese of Gloucester and Bristol, and his successors, Bishops of the same diocese, for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forth-
