"Market or Fair within that jurisdiction, for a Order, or some specified description thereof, from time to be specified in such Notice, it is hereby Markets or Fairs within the jurisdiction of such Tocal Authority; It shall not be lawful, from and after the date of this Order and while such Notice shall be in-force, for any person to bring or send any such animals or such description thereof to any place within such jurisdiction for the purpose of exhibition or sale, or to receive, exhibit, buy, or sell any such animals so brought or sent: Provided that nothing contained in this Clause of this Order shall be held to prohibit any person from exhibiting or selling on his own land or premises any such animal belonging to him, which has been on such land or premises for not less than fourteen days previous to such sale.

2. Every person offending against this Order shall, in pursuance of the said Act, for every such offence forfeit any sum not exceeding twenty pounds which the Justices before whom he or she shall be convicted of such offence may think fit to impose to impose.
