Whereas Sir Edward Samuel Walker, Knight, Francis Hall, James Salmond, Walter Need, Esquires, and the Reverend John Lawrence Prior, Clerk, being five of Her Majesty's Justices of the Peace, acting in and for the county of Nottingham, have, by writing under their hands dated the 21st day of September, 1865, required Thomas Fowke Andrew Burnaby, Esquire, Clerk of the Peace for the said county, to add to or send with the notice required by law to be given of the holding of the Court of General or Quarter Sessions of the Peace for the said county, a notice in the form required by the provisions of an Act pussed in the 25th and 26th years of the reign of Her Majesty Queen Victoria, cap. 61, intituled "An Act for the better management of Highways in England," and of an Act passed in the 27th and 28th years of the reign of Her Majesty, Queen Victoria, cap. 101, intituled "An Act to amend the Act for the better management of Highways in England," that at the then ensuing General Quarter Sessions of the Peace, a proposal would be made to the Justices then and there assembled to combine the townships, hamlets, or places of Selstone, Bagthorpe, Jacksdale, Underwood, and Westwood, which separately maintain their own highways, and are situate in the parish of Selstone, in the county of Nottingham, a parish separately maintaining its own poor; and to declare that no separate waywardens should be elected for such townships, hamlets, or places; and that such parish should be subject to the same liabilities in respect of all the highways within it, which were before maintained by such townships, hamlets, or places separately, as if all their several liabilities had attached to the whole parish; and that a Waywarden or Waywardens should be elected for such parish as a whole: And whereas such requisition has been duly complied with: And whereus, at this present General Quarter Sessions of the Peace, a proposal was submitted to the said Court by the suid five Justices, that the said hamlets or places of Jacksdale and West-
