#### CATTLE PLAGUE.

NOTICE is hereby given, that under the authority of an Order of Her Majesty's Most Honourable Privy Council made on the 23rd day of November, 1865, and of the several statutes in that behalf made by Her Majesty's Justices of the Peace acting in and for the Petty Sessional Division of Whitby Strand, in the North Riding of the county of York, assembled at a Petty Session holden on the 2nd day of this instant month of December, did declare, that in order to prevent the spreading of the cattle plague it is expedient that no cow, heifer, bull, bullock, ox, calf, sheep, lamb, goat, or swine, shall, for the space of six weeks from the date hereof, be brought from any other part of Great Britain into any place within the said Petty Sessional Division. Provided that fat animals of the descriptions aforesaid may be brought by rail into the said division, subject to the following regulations, namely :—such fat animals as shall be brought into the town of Whitby shall not be taken beyond the limits of the boundary thereof, as defined by the Whitby Improvement Act, and shall be slaughtered within a period of ten days after their arrival in Whitby, and such fat animals as shall be so brought to any other railway station or place within the said division shall not be driven to a greater distance than half a mile from such station or place, and in all cases where the owner of such fat animals shall occupy a slaughterhouse within the said distance of half a mile they shall be driven to such slaughterhouse only.

And no store or lean animals of the descriptions aforesaid shall be driven through the town of Whitby aforesaid, or brought within the limits of the boundary thereof as before mentioned, nor shall any animals whatsoever of the descriptions aforesaid, whether fat or lean, be removed to any fair, market, or other place within the said division for the purpose of exhibition or sale.

Every person offending against the tenor of this notice will, for each such offence, be liable to such penalty not exceeding £20, as the Justices before whom he or she may be convicted may think fit to impose.

#### CATTLE PLAGUE.

*Division of West Ward, in the county of Westmorland.*

West Ward Petty Sessions, Hackthorpe, 4th December, 1865.

(Present, Rev. W. R. Markham, Rev. J. S. Sisson, John Jameson, Esq., James Atkinson, Esq., and Colonel Rigg.)

In pursuance of the Order of Her Majesty's Most Honourable Privy Council, dated the 23rd day of November, 1865, it is hereby declared that it is expedient to prevent the removal of all animals described in the said Order, viz., cows, heifers, bulls, bullocks, oxen, calves, sheep, lambs, goats, and swine, to any market or fair, or to any place whatever, for the purpose of exhibition or sale, within the Petty Sessional Division of West

Ward aforesaid, from the date of this notice until the 1st day of February next.

And, in pursuance of the same Order, it is hereby further declared that it is expedient, from the date of this notice until the said 1st day of February next, that animals of the before-mentioned description shall not be brought from any other part of Great Britain into any place within the said Petty Sessional Division of West Ward.

And notice is hereby given, that it will not be lawful, after the publication of this notice, for any person to bring or send any animal of the before-mentioned description into any market or fair, or to any place within the said Petty Sessional Division of West Ward, for the purpose of exhibition or sale, or to receive any such animals so brought or sent.

Also that it will not be lawful, after the publication of this notice, for any person to bring or send any animal of the before-mentioned description from any place in Great Britain beyond the said Petty Sessional Division of West Ward, into any place within the said division.

And that every person offending herein will, for every such offence, be liable to a penalty of not exceeding twenty pounds.

#### CATTLE PLAGUE.

NOTICE is hereby given, that in order to prevent the spreading of the cattle plague, and by authority of the 18th section of the Order in Council, dated the 23rd day of November, 1865, the Justices of the Peace assembled in Petty Session, and acting in and for the division of Langbaugh West, in the North Riding of the county of York, have declared that it is expedient that no cow, heifer, bull, bullock, ox, calf, sheep, lamb, goat, or pig shall be brought from any part of Great Britain into any place within the said division of Langbaugh West, from the date of this notice until the 1st day of March next.

Animals may be sent or carried through the division of Langbaugh West by railway.

Any person with the license of any two Justices of the Peace, acting in and for the division of Langbaugh West, may bring or send animals from any land or premises in his own occupation, beyond the said division, to any other land or premises in his own occupation within the said division.

Every person offending against this notice will, for each such offence, be liable to a penalty not exceeding twenty pounds.
