the said borough, except under the conditions hereinafer mentioned.

1. That, subject as aforesaid, no animal brought by water, railway, or otherwise shall be landed within, or be allowed to enter the said borough, except for the purpose of being slaughtered, and not even then, until after the inspector of the district shall, in each case, have certified that the same is free from disease.

That every such animal shall be slaughtered within forty-eight hours from the time when such inspector shall have given his said

certificate.

3. That, upon receipt of such certificate, all such animals shall, on and after Wendesday next, be immediately taken to the New Cattle Market and to the slaughter-house within the said borough, prior to their being so slaughtered as aforesaid, whither they shall continue to be taken until the said inspector, by my authority, shall appoint any other place fit for their reception.

PENALTY.

Any person after this date offending against the said Orders or against the above notice, declaration, and conditions, will, for every such offence, be liable to forfeit the sum of £20.

This notice will be in force until the 1st day

of March next.

I, the undersigned, James Sidebottom, Esquire, Mayor of the borough of Stalybridge, in the counties palatine of Lancaster and Chester, by virtue of an Order of the Lords of Her Majesty's Most Honourable Privy Council, dated the 16th day of December, 1865, and of a previous Order in Council, dated the 23rd day of November, 1865, do hereby declare that it is expedient with a view to prevent the spreading of the disorder, generally designated the "Cattle Plague," that on and after Saturday, the 20th day of January instant, and until the 1st day of March next, no cow, heifer, bull, bullock, ox, or calf, shall be brought from any part of Great Britain into any place within the said borough except as provided by the said Orders in Council, and that it is also expedient to prevent the removal of any such animal to any market or fair, or to any place whatever within the said borough, for the purpose of exhibition or sale, or from place to place therein, except as provided by the said Orders in Council, and under certain conditions.

And I do hereby further declare, that it shall not be lawful after Saturday, the 20th day of January instant, and until the 1st day of March next, for any person to bring or send any cow, heifer, bull, bullock, ox, or calf, from any part of Great Britain into any place within the said borough, except such as shall be fat and intended for immediate slaughter, and shall be slaughtered within forty-eight hours after being brought within the said borough. And that it shall not be lawful for any person to bring or send any w, heifer, bull, bullock, ox, or calf, to any

market or fair, or to any place whatever within the said borough for the purpose of exhibition or sale.

And that it shall not be lawful for any person to remove or cause to be removed any such animal or animals from any place within the said borough to any other place within the said borough, nor along any turnpike road or other highway for general traffic, without the licence in writing of a Justice of the Peace for the said borough.

And I hereby give notice that any person offending against the provisions of this notice will be liable for each offence to a penalty not

exceeding £20.
