

except within the limits of the parish in which the same has been fed or kept.

§ 6th. That it shall not be lawful to remove from any farm or lands whereon the Cattle Plague exists to any other place whatsoever, any skins, hoofs, hides, or horns.

And notice is hereby given, that any person offending against any or either of the said Orders of the Court of Quarter Sessions will be liable to a penalty for each offence of £20.

And it is further ordered, that the Clerk of the Peace do cause the said Resolutions to be inserted in all the newspapers published and circulated within the jurisdiction, and in one of the newspapers published and circulated within the county of Worcester, the Midland Counties Herald, and in the London Times.

### CATTLE PLAGUE.

*County of Edinburgh.*

NOTICE is hereby given, that Her Majesty's Justices of the Peace for the county of Edinburgh, in Special General Sessions assembled, at Edinburgh, of the date hereof, in terms of the powers conferred upon them by the Orders of the Lords of Her Majesty's Most Honourable Privy Council, of date 23rd November, and 16th December, 1865, declared, and hereby declare, in terms of said Orders, that the notices issued by them, of date 15th December, 1865, and 3rd January, 1866, are hereby revoked.

And the said Justices further hereby declare, in terms of the said Orders, that with a view to prevent the spreading of the Cattle Plague, it is expedient, from this date till the 1st day of March next, to prevent, and they therefore do hereby prohibit, from this date to the 1st day of March next, the removal of any cow, heifer, bull, bullock, ox, or calf, from place to place within the jurisdiction of the said Justices, along any public road, highway, or public way, whether for the purpose of exhibition or sale, or for any other purpose whatever, except under the following conditions, viz. :—

Notwithstanding this notice, any cow, heifer, bull, bullock, ox, or calf, may be removed from any place within the said jurisdiction, to the market of Edinburgh, or to any local butcher direct, to be slaughtered within forty-eight hours after reaching his custody, or to the nearest railway station (with reference to its destination) to be forwarded to any market to be sold for slaughter, but without the power of being brought back alive, provided always, that the owner or person having the charge of such cow, heifer, bull, bullock, ox, or calf, shall procure, not more than three days previous to removal, a certificate by an Inspector, that the said cow, heifer, bull, bullock, ox, or calf, is in a sound state of health, and that no animal on the same farm or premises is, or so far as known to said Inspector, has been affected with Cattle Plague, and also a licence by two Justices of the Peace for the county of Edinburgh.

And the said Justices do hereby further declare that it is expedient, from this date to the 1st day of March next, to prevent, and they do therefore hereby prohibit, from this date to 1st day of March next, the removal of any sheep, lamb, goat, or swine, from any place whatever within their jurisdiction, to any market or any place whatever within their jurisdiction, for the pur-

pose of exhibition or sale, except under the following conditions, viz. :—

Notwithstanding this notice, any sheep, lamb, goat, or swine, may be removed from any place within the said jurisdiction to the Market of Edinburgh, or to any local butcher direct, to be slaughtered within forty-eight hours of its reaching his custody, or to the nearest railway station (with reference to its destination) to be forwarded to any market to be sold for slaughter, but without the power of being brought back alive.

And the said Justices do further hereby declare that it is expedient, with a view to prevent the spreading of the said disorder, that from this date to the 1st day of March next, no cow, heifer, bull, bullock, ox, calf, sheep, lamb, goat, or swine, shall be brought into any place within the jurisdiction of the said Justices, viz., the county of Edinburgh, from any place in Great Britain beyond their jurisdiction. And it is hereby declared that the bringing or sending of any cow, heifer, bull, bullock, ox, calf, sheep, lamb, goat, or swine, from any place in Great Britain beyond the jurisdiction of the said Justices into any place within their jurisdiction is prohibited from this date to the 1st day of March next.

Every person offending against the above notice is liable to be prosecuted for a penalty not exceeding £20 for each offence.

The forms to be used by Inspectors and Justices will be found in the hands of the various Inspectors for the county, or supplied at the office of the Clerk of the Peace, or of the Chief Constable, County Rooms, Edinburgh.

NOTE.—Nothing contained in the above notice makes it unlawful for any person to send or carry any animals by railway through the jurisdiction of the Justices for the county of Edinburgh, nor to bring or send with the licence of any two Justices acting in and for said jurisdiction, any animals from any land or premises in his own occupation, and beyond such jurisdiction to any other land or premises in his own occupation within such jurisdiction.

### CATTLE PLAGUE.

*Borough of Dover, in the county of Kent.*

By virtue of an Order in Council, dated the 16th day of December, 1865, I, William Rigden Mummery, Esq., Mayor of the borough of Dover, the local authority for the jurisdiction of the said borough under the said Order, do hereby, by this notice published in the manner directed in the said Order, declare it to be expedient that from the 29th day of January instant, until the 1st day of March next, no cow, heifer, bull, bullock, ox, or calf, shall be brought or removed from any place without the said borough to any place within the said borough, nor be on, pass over, along, or across any highway or public road within the borough, except upon the following conditions, viz. :—

1. That the Inspector appointed for the District of the said borough shall have previously examined such cow, heifer, bull, bullock, ox, or calf, and the same shall have been marked by him; and

2. That such cow, heifer, bull, bullock, ox, or calf, shall be slaughtered within forty-eight hours after the same shall have been brought or removed to within the said borough, or have been on, passed over, along, or across, such highway, or public road as aforesaid.
