middle of the said lane, for a distance of sixtyfour chains, or thereabouts, to the watercourse called 'Peat Cleugh Sike;' and extending thence eastward along the middle of the said Pest Cleugh Sike (following its southernmost channel), to its junction with Ireshope Burn; and extending thence south-westward along the middle of such Burn to its junction with the stream which flows through Groove Cleugh; and continuing thence still south-westward along the middle of the lastdescribed stream, to the point where the stream flowing from Frances Cleugh unites with the stream flowing from Pencil Cleugh; and extending thence southward, and in a direct line for a distance of forty-one chains, or thereabouts, to the point where the foot-path, leading from Causeway Hill to Langdon Head, crosses the boundary which divides the said parish of Stanhope from the parish of Middleton, in Teesdale, in the said county and diocese of Durham.

The SECOND SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of St. John-in-Wear-dale being;—

"All that part of the parish of Stanhope, in the county of Durham, and in the diocese of Durham, which is comprised within, and is bounded by an imaginary line commencing at the point where the footpath which leads from Causeway Hill to Langdon Head crosses the boundary which divides the said parish of Stanhope from the parish of Middleton-in-Teesdale, in the county and diocese aforesaid; and extending thence in a direction generally south-eastward along the said parish boundary to the point (distant about five miles from the firstdescribed point) where the said parish boundary is met by the boundary which divides Swinhope Moor from Westernhope Moor; and extending thence northward along the last-described boundary for a distance of thirty-five chains, or thereabouts, to the south-eastern corner of Swinhope inclosed allotments; and extending thence northeastward to and along the middle of the fence which divides the said Swinhope allotments from Blackhill allotment, following the line of Blackhill Edge to the junction of the said fence with the fence dividing the last-named allotment from East and West Lee Pastures; and extending thence eastward along the middle of the last-described fence to its junction with the northern boundary of Fallow Hill; and extending thence south-eastward along the last-described boundary to a point in the middle of Westernhope Burn; and extending thence first north-eastward, and then north-westward along the middle of the said Burn to its junction with the River Wear; and extending thence south-westward along the middle of the said river for a distance of twenty-seven chains, or thereabouts, to a point opposite to the middle of the southern end of the watercourse called 'Yellock Sike;' and extending thence first northward, and then north-westward to and along the middle of the said watercourse (passing thereby under the Lobley Hill turnpike-road, and also under the line of the Rookhope and Middlehope Railway), to the junction of the said watercourse with Park Burn; and continuing thence, still north-westward, along the middle of Park Burn to the western boundary of Northgate Fell; and continuing thence, still north-westward, along the said western boundary to its junction at Windy Hill with the boundary which divides the township of Park Quarter, in the said parish of Stanhope, from the township of Forest Quarter, in the same parish; and extending thence, north-west-

ward, along the said township boundary to the extreme north-western angle of the said township of Park Quarter called Middlehope Head; and extending thence, first southward and then southeastward, along the same boundary as far as the point where it meets the northern side of Sedling Rake-road; and extending thence, north-westward, along the northern side of such road for a distance of thirteen chains, or thereabouts, to a point opposite to the middle of the north-eastern end of the stream which flows down the centre of Elmford Cleugh; and extending thence, southwestward across the said road, to and along the middle of such stream to its junction with the River Wear; and extending thence, south-eastward, along the middle of the said river as far as the centre of Blackdean Bridge, which carries over such river the road leading from West Black Dean; and extending thence, in a direction generally south-westward, along the middle of the last-described road to its junction with the road leading from Ireshope Burn to Wearhead; and extending thence, north-westward, along the middle of the last-described road for a distance of twenty-one chains, or thereabouts, to a point opposite to the house called 'Lane Side;' and extending thence, south-westward and in a direct line, for a distance of thirty-one chains or thereabouts (passing close to the west of the house called 'Ullsfield'), to a point in the middle of Grasshill Causeway about midway between the house called Ling Riggs and the house called Winter Gap; and extending thence north-westward along the middle of the last-named road, for a distance of six chains, or thereahouts, to a point opposite to the last-named house, and also opposite to the middle of the north-eastern end of Low-lane; and extending thence south-westward to and along the middle of the said lane, for a distance of sixty-four chains, or thereabouts, to the watercourse called 'Peat Cleugh Sike; and extending thence eastward along the middle of the said Peat Cleugh Sike (following its southernmost channel), to its junction with Ireshope Burn; and extending thence south-westward along the middle of such Burn to its junction with the stream which flows through Groove Cleugh; and continuing thence, still south-westward, along the middle of the lastdescribed stream, to the point where the stream flowing from Frances Cleugh unites with the stream flowing from Pencil Cleugh; and extending thence southward and in a direct line, for a distance of forty-one chains, or thereabouts, to the first-described point where the footpath which leads from Causeway Hill to Langdon Head crosses the boundary which divides the said parish of Stanhope from the parish of Middleton-in-Teesdale, as aforesaid.

The Third SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Rookhope, being:-

"All that part of the parish of Stanhope, in the county of Durham and in the diocese of Durham, which is situate generally to the north of an imaginary line commencing at Dead Friar's Stone, being the point where the boundary which divides the parish of Edmondbyers, in the said county and diocese, from the parish or parochial chapelry of Hunstanworth, in the same county and diocese, meets the northern boundary of the said parish of Stanhope; and extending thence south-westward and in a direct line for a distance of two miles and thirty-four chains, or thereabouts, passing over the top of Bell's Hill, and crossing Stanhope Burn, and passing over the top of Long Hill.
