numbered 590 as aforesaid, with the fence dividing the plantation called 'Blunt's Wood,' and numbered 596 upon the said maps, from the close numbered 590 as aforesaid; and extending thence in a direction mainly southward along the middle of the said fence, and along the middle of the fences dividing the plantation called 'Blunt's Wood,' and numbered 596 as aforesaid, and the closes numbered respectively 595, 424, 426, 393, 390, and 389 upon the said maps, from the road leading from Harlands to the said plantation, and from the closes numbered respectively 587, 585, 581, 583, 580, and 394 upon the same maps, to the southern extremity of the fence dividing the close numbered 389 from the close numbered 394 as aforesaid, at the point near Butler's Green, where the road leading from Hayward's Heath to Saint John's Common diverges from the road leading from Hayward's Heath to Cuckfield; and extending thence still southward to the middle of the said road leading from Hayward's Heath to Saint John's Common aforesaid, and then southwestward along the middle of the same road for a distance of about eleven chains and three-quarters to a point opposite to the middle of the northwestern end of the Bolnore bridle-road; and extending thence south-eastward to and along the middle of the said bridle-road for a distance of about eighteen chains to a point opposite to the middle of the north-eastern end of the fence dividing the close numbered 453 upon the said maps from the close numbered 455 upon the same maps; and extending thence south-westward to and along the middle of the last-described fence, and along the middle of the fences dividing the said close numbered 453, and the closes numbered respectively 459 and 460 upon the said maps from the closes numbered respectively 454 and 458 upon the same maps to a boundary stone inscribed 'C. St. W. D. C., 1866, No. 2,' and placed upon the boundary which divides the said parish of Cuckfield from the new parish of Saint John's Common, in the county and diocese aforesaid, at or near to the middle of the south-western extremity of the fence which divides the close numbered 460 from the close numbered 458 as aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chichester.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years I the middle of Bootle-road; and extending thence

of Her Majesty, chapter fifty-five; duly prepared and laid before Her Majesty in Council a representation, bearing date the eighth day of February, in the year one thousand eight hundred and sixty-

six, in the words following; that is to say:
"We, the Ecclesiastical Commissioners for
England, in pursuance of the Act of the fiftyninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five; have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint John, situate within the township of Bootle-cum-Linacre, in the parish of Saint Mary, Walton-on-the-Hill, in the county of Lancaster, and in the diocese of Chester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint John, situate within the township of Bootle-cum-Linacre aforesaid.

"Now, therefore, with the consent of the Right Reverend William, Bishop of the said diocese of Chester (testified by his having signed and sealed this representation), we humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Saint Mary, Walton-on-the-Hill, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned to the said church of Saint John, situate within the township of Bootle cum-Linacre aforesaid, and that the same should be named 'The District Chapelry of Saint John, Bootle.

"And, with the like consent of the said William, Bishop of the said diocese of Chester (testified as aforesaid), we further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, and churchings should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that so long as the Reverend Thomas Hornby, the present vicar or incumbent of the vicarage of the said parish of Saint Mary, Walton-on-the Hill, shall remain such vicar or incumbent, all the fees which may be received in respect of the performance of the said offices in the church aforesaid, shall be paid by the minister thereof to the said Thomas Hornby.

We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint John, Bootle, being :-

"All that part of the parish of Saint Mary, Walton-on-the-Hill, in the county of Lancaster, and in the diocese of Chester, which is comprised within that portion of the township of Bootlecum-Linacre, which is situate to the west of an imaginary line commencing upon the boundary which divides the said township from the township of Kirkdale, in the same parish, at a point in
