## County of Worcester.—Adjourned Sessions, 17th March, 1866.

THE Justices assembled at the adjourned . Quarter Sessions, held at the County Hall, Worcester, in and for the said county, on the 17th day of March, 1866, by virtue of the powers vested in-.them.as the local authority in the county of Wor-

cester by the Orders in Council, dated respectively ... the 23rd day of November, 1865, the 16th day of . December, 1865, the 20th day of January, 1866, and the 28rd day of February, 1866; or one of them, do declare as follows :- ...

in min That with a view to facilitate the removal of , cattle upon a change of tenancy, it is expedient that for a period of fourteen days from and after the 19th day of March instant, any cow, heifer, bull, bullock, ox, calf, sheep, lamb, goat, or swine, may, upon any change of tenancy, be removed from any uninfected district in any adjoining county into any uninfected district in this county :

Provided that no removal as above authorised of any animal shall take place without a licence, signed by a Justice of the Peace resident in the county from whence the same is to be removed, and also a licence signed by a Justice of the Peace resident in this county.

2. That with the view to check the spreading of the disorder generally designated as the "Cattle Plague," it is expedient, from the 17th day of March instant until this declaration is revoked, that no cow, heifer, bull, bullock, ox, calf, sheep, lamb, goat, or swine; or any raw or untanned hides, skins, horns, or hoofs of any such animal as aforesaid, shall be removed out of or from any part of the district comprised within a radius of two miles from the farm-house called the Hill Wood Farm, in the occupation of Mr. Holder, in the parish of Eastham, in this county, into any parish or place adjoining the district within such radius of two miles as aforesaid, or from one farm to another within the said distance of two miles from the said farm-house.

3. That it is also expedient that, from the 17th -day of March instant, so much of the several declarations of this Court, dated the 30th day of January and the 6th day of February last, as prohibit the removal of any cow, heifer, bull, bullock, ox, calf, sheep, lamb, goat, or swine, or of any raw or untanned hides, skins, horns, or hoofs of any such animals as aforesaid, out of the parish of Knighton-on-Teme, in this county, or from one farm to another within the said parish shall be and the same is hereby revoked :

Provided that no animal as aforesaid (except swine) shall be removed out of the said parish of Knighton-on-Teme, or from one place to another within the said parish, except with and subject to a licence of a Justice of the Peace, to be granted in accordance with the declaration of this Court, dated the 3rd day of January last (subject, nevertheless, to the reservation contained in such last-mentioned declaration relative to removal of -animals for change of pasture or breeding purposes).

4. The declarations of this Court in respect of --such disease designated as the "Cattle Plague," ····· A 2.

made on the 3rd and 30th days of January and the 6th day of February last, are to the foregoing extent only hereby altered, varied, and revoked.

Every person offending against the tenor hereof will, for every offence, forfeit any sum not exceeding twenty pounds, which the Justices before whom he or she shall be convicted may think fit to impose.

Lady the Queen, holden at Lewes, in and for the county of Sussex, on Monday, the 1st day of January, in the 29th year of the reign of our Sovereign Lady Victoria, by the Grace of God of the United Kingdom of Great Britain and Ireland Queen, Defender of the Faith, and in the year of our Lord 1866, and from thence continued by divers adjournments to and holder, at Lewes, in and for the said county; on Tuesday, the 13th day of March, in the year last aforesaid, before the Right Honourable Henry Thomas Earl of Chichester, George Darby, Esquire, and others their fellows, Justices of our said Lady the Queen, assigned to keep the Peace in the said county, and also to hear and determine divers felonies, trespasses, and other ill deeds done and committed in the county aforesaid.

It is ordered by this Court; holden by adjournment as aforesaid-That from and after the 13th day of March, 1866, no cow, heifer, bull, bullock, ex, or calf, shall be removed from any place within the Western Division of the county of Sussex, or so much of such Western Division as is within the same jurisdiction, into or through any, part of the Eastern, Division of the said county; or so much thereof as is within the jurisdiction of the said Justices ; provided always, that it shall be lawful for any such animal or animals to be removed from any land within the Western Division of the county of Sussex, within the jurisdiction of the Justices aforesaid; into any land being in the same occupation as the land above mentioned, within the Eastern Division of the said county, provided that the said animal or animals be removed by a licence, granted by a Justice of the Peace acting in and for the Petty Sessional Division into which such animal or animals are by such licence to be removed, provided also that such animal or animals should have been in the possession of the occupier of the land from which they are to be removed for one month.
