

south-westward along the last-described parish boundary, which is also the county boundary to its junction with the boundary dividing the said parish of Aldershot from the new parish of Saint John, Hale aforesaid; and extending thence, first northward and then north-westward, along the last-described parish boundary, continuing thereby to follow the county boundary aforesaid as far as the centre of Spray-bridge, which carries the road leading from Ash past the northern side of Badshot Lea, and past Weybourne to Heath End and Crondall; and extending thence, first south-westward and then westward, along the middle of the last-described road for a distance of two-thirds of a mile, or thereabouts, passing the northern side of Badshot Lea as aforesaid to a point near Weybourne aforesaid, opposite to the middle of the northern end of a certain cross road leading past Hog Stye Green and the Osier Bed to Farnham; and extending thence, southward, to and along the middle of the said cross road for a distance of rather more than half a mile to its junction with the road leading from Farnham through Badshot Lea to Spray's-bridge aforesaid; and extending thence, north-eastward, along the middle of the last-described road for a distance of one-third of a mile, or thereabouts, to its junction with the lane leading from Crump's farm, at a point opposite to the middle of the western end of the fence dividing the closes numbered respectively 1793 and 1805 upon the tithe commutation map of the said parish of Saint Andrew, Farnham, and upon the map hereunto annexed from the closes numbered respectively 1783, 1784, 1791, and 1789 upon the same maps; and extending thence eastward to and along the middle of the said fence for a distance of nearly one-third of a mile (passing to the south of the houses which are situate on the southern side of Badshot Lea aforesaid) to a point opposite to the middle of the eastern end of such fence, in the middle of Runfold-lane; and extending thence in a direction mainly southward along the middle of the same lane to its junction with the turnpike road leading from Farnham to Guildford aforesaid; and extending thence westward along the middle of such turnpike road as far as the boundary which divides the said new parish of Saint John, Hale, from the parish of Saint Andrew, Farnham aforesaid; and extending thence south-eastward along the said boundary, following thereby the middle of a certain road leading to Sandy Farm to the junction of such boundary with the boundary dividing the said new parish of Saint John, Hale, from the parish of Seale aforesaid; and continuing thence, first south-eastward, then north-eastward, and finally north-westward along the last-described boundary to the point at the four-cross roads called Whiteway's End, where the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Winchester.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, sections six and eight, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-second day of March, in the year one thousand eight hundred and sixty-six, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act of the sixth and seventh years of your Majesty, chapter thirty-seven, sections six and eight, have prepared, and now humbly lay before your Majesty in Council, the following scheme for authorizing the sale and disposal of certain property formerly belonging to the prebend of Putson Major, in the cathedral church of Hereford, and now vested in us.

"Whereas, under an Act of the third and fourth years of your Majesty, chapter one hundred and thirteen, and of another Act of the fourth and fifth years of your Majesty, chapter thirty-nine, and by virtue of an Order of your Majesty in Council, made under the provisions of the same Acts, and bearing date the eighteenth day of May, in the year one thousand eight hundred and sixty-five, and duly published in the London Gazette on the nineteenth day of the same month, all lands, tithes, and other hereditaments, then belonging to the said prebend (except rights of patronage), became absolutely vested in us, for the purposes and subject to the provisions applicable to other hereditaments vested in us.

"And whereas the lands, tithes, and hereditaments aforesaid, consist, to a considerable extent, of reversions expectant upon leases for lives, and produce during the subsistence of such leases only small annual revenues, and on that account, and in some instances on account of the character or situation of the property, are unsuitable or inconvenient to be held or applied for the purposes for which estates vested in us are applicable under the Acts by which our proceedings are governed.

"And whereas by an Act of the twenty-third and twenty-fourth years of Your Majesty, chapter one hundred and twenty-four, power is given to lessees holding under us, in the event of our declining to enter into a treaty for the sale of our reversions, or the purchase of the leasehold interests, to require us to purchase such leasehold interests at a valuation.

"And whereas, with a view to the advantageous appropriation of the said lands, tithes, and hereditaments, or of the proceeds thereof, for the ultimate improvement of our Common Fund, it is expedient that the said lands, tithes, and hereditaments, or such parts thereof as we shall at any time, and from time to time, think fit, should be sold or disposed of, and accordingly that we should be empowered to dispose of our interest in such lands, tithes, and hereditaments, or in any part or parts thereof, in such manner as shall appear to us advisable.

"Now, therefore, we humbly recommend and propose, that we may be authorized and empowered, by instrument or instruments in writing, duly executed according to law, from time to time to sell or dispose of, and duly to convey, according to the provisions of the said Act of the sixth and seventh years of your Majesty's reign, with
