the consent of the respective holders (if any), to be testified by their being made parties to such instruments, all or any of the said lands, tithes, and hereditaments heretofore belonging to the said prebend, and so vested in us as aforesaid, with their appurtenances, and all our estate, right, title, and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs, executors, administrators, or assigns, or otherwise as he or they shall direct or appoint, and for such consideration as shall, upon due calculation and inquiry, appear to us to be just and reasonable.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Hereford.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen; and of the Act of the seventeenth and eighteenth years of Her Majesty, chapter eighty-four; duly prepared, and laid before Her Majesty in Council a scheme, bearing date the eighth day of March, in the year one thousand eight hundred and sixty-six, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter one hundred and thirteen; and of the Act of the seventeenth and eighteenth years of your Majesty, chapter eighty-four; have prepared, and now humbly lay before your Majesty in Council, the following scheme for making better provision for the cure of souls within the new parish of Christ Church, Freemantle, sometime part of the parish of Millbrook, in the county of Southampton, and in the diocese of Winchester.

"Whereas the Bishop of the diocese of Winchester, for the time being, is, in right of his see, the patron of the perpetual curacy of the said new parish of Christ Church, Freemantle, and also of the rectory of the said parish of Millbrook.

"And whereas it has been made to appear to Acts, or of a us that the church of the said new parish of Parliament.

Christ Church, Freemantle, is at present ill endowed, and that it is desirable that some additional provision should be made for the cure of souls within the said new parish.

"And whereas the Right Reverend Charles Richard, Bishop of Winchester, the Bishop of the diocese, and the patron in right of his see of the rectory of the parish of Millbrook as aforesaid, has proposed to us, and it appears to us to be expedient, that the income of the said rectory should be apportioned between the rector or incumbent thereof, and the incumbent of the said perpetual curacy of the new parish of Christ Church, Freemantle, in the manner hereinafter recommended and proposed.

"Now, therefore, with the consents of the Right Honorable and Most Reverend Charles Thomas, Archbishop of Canterbury, of the said Charles Richard, Bishop of the said diocese of Winchester, and of the Reverend Alexander Colvin Blunt, Clerk, the present rector or incumbent of the rectory of the said parish of Millbrook (in testimony whereof they have respectively signed and sealed this scheme), we humbly recommend and propose that the tithes or rent-charges in lieu of tithes issuing, arising, and payable out of, or in respect of, certain lands, tenements, and hereditaments, situate within the new parish of Christ Church, Freemantle aforesaid, and now forming part of the endowments of the said rectory of the said parish of Millbrook, which are set forth and described in the Schedule hereunto annexed, shall, without any conveyance or assurance in the law other than this scheme, and any duly gazetted Order of your Majesty in Council ratifying the same, and upon and from the day of the date of the publication of such Order in the London Gazette, be disannexed and transferred from the rectory of the said parish of Millbrook, and from the rector or incumbent thereof and his successors, and shall become and be absolutely vested in the Reverend Abraham Sedgwick, the incumbent of the perpetual curacy of the said new parish of Christ Church, Freemantle, and in his successors, the incumbents of the same new parish, for ever, and shall become, and be, and form part of, the endowments of such new parish.

"And, with the like consents of the said Charles Thomas, Archbishop of Canterbury, of the said Charles Richard, Bishop of the said diocese of Winchester, and of the said Alexander Colvin Blunt (testified as aforesaid), we further recommend and propose that the sum of one thousand two hundred and seventy-eight pounds fifteen shillings and six-pence, Three Pounds per centum Reduced Bank Annuities, being an endowment held by the Governors of the Bounty of Queen Anne for the augmentation of the maintenance of the Poor Clergy, in trust, for the rector for the time being of the parish of Millbrook aforesaid, shall, upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme as aforesaid, be held by the said Governors, in trust, for and for the benefit of the then incumbent of the said new parish of Christ Church, Freemantle, and his successors, incumbents of the same new parish, for ever, and shall become and be and form part of the endowments of such new parish.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament.
