TABLE OF FEES ABOVE REFERRED TO:

Whereas a certain Table of Fees was duly established and ordained on the 5th day of January, 1830, pursuant to the provisions of the Act passed in the tenth year of His Majesty George the Fourth, entitled "An Act to regulate the duties, salaries, and emoluments of the officers, clerks, and ministers of certain Ecclesiastical Courts in England," as the Table of Fees to be hereafter taken by the several officers, clerks, and ministers of the Arches Court of Canterbury.

And whereas certain new Rules and Regulations have been recently ordered for the purpose of making the procedure and practice of the said Court more simple and expeditious, and imposing new duties on the Registrar, it has in consequence become necessary to establish and ordain certain reasonable new or additional Fees: we do, in further pursuance of the provisions of the said Acts in respect thereof, hereby establish and ordain the following new or additional Fees to be hereafter taken by the Registrar of the said Court, as reasonable Fees for the acts to be done and performed by the said Registrar in carrying out, performing, and executing certain acts, matters, and things required in and by the said Rules.
