leading from Alkrington Hall towards Crab-lane Head, and opposite to a boundary stone inscribed B. St. A. D., 1866, No. 1,' and placed on the northern side of such lane; and extending thence south-westward along the middle of the said lane for a distance of forty-eight chains or thereabouts (passing Cooper Fold, and Yew Tree House) to a point opposite to a boundary stone inscribed 'B. St. A. D., 1866, No. 2,' and placed on the southern side of such lane, at or near to its junction with a certain footpath connecting the said lane with a certain occupation road leading to Lower Plant Hill; and extending thence generally south-eastward to and along the middle of the said footpath, and along the middle of the said occupation road, for a distance of twenty chains or thereabouts to a point near Lower Plant Hill aforesaid, opposite to a boundary stone inscribed 'B. St. A. D., 1866, No. 3,' and placed on the western side of the said occupation road, at the north-eastern end of the fence which divides the close numbered 817 upon the tithe commutation map of the township of Blackley, in the said parish of Manchester, and upon the map hereunto annexed from the close numbered 482 upon the same maps; and extending south-westward from the middle of the said occupation road to the lastdescribed boundary stone, and along the middle of the said fence; and continuing generally in the same direction along the middle of the streams or fences which divide the closes numbered respectively 818, 485, 420, 556, 555, and 552 upon the said maps from the closes numbered respectively 482 as aforesaid, 481, 419, and 416 upon the same maps to a boundary stone inscribed 'B. St. A. D., 1866, No. 4,' and placed at the south-western extremity of the fence dividing the close numbered 552 from the close numbered 416 as aforesaid on the northern side of Crab-lane; and continuing thence first south-westward to a point in the middle of Crab-lane aforesaid, and then southeastward along the middle of the same lane for a distance of one chain or thereabouts to a point opposite to the middle of the northern end of the fence dividing the close numbered 561 upon the said maps from the close numbered 578 upon the same maps; and extending thence first southward, then south-westward, and again southward to and along the middle of the last-described fence to a boundary stone inscribed 'B. St. A. D., 1866, No. 5,' and placed at the south-western end of the last-described fence, on the northern side of a certain occupation road leading to Hamer Hill; and continuing still south-westward from such boundary stone along the middle of the said occupation road, and along the bottom of the valley which drains into the reservoir of the Ashenhurst Works, to the northern end of the said reservoir; and continuing thence still south-westward along the western bank of the same reservoir to its south-western corner on the northern side of the new road which leads from Bowker Vale to Blackley; and extending thence southward in a direct line (crossing the said new road) to the boundary at the north-eastern corner of the buildings known as the Ashenhurst Works aforesaid, which said boundary divides the new parish of Saint Peter, Blackley aforesaid, from the new parish of Saint Mary, Crumpsall, in the county of Lancaster, and in the diocese of Manchester afore-

And whereas a draft of the said scheme has been, in accordance with the provisions of the hereinbefore firstly mentioned Act, transmitted to the incumbent and to the patrons of the new parish of Saint Peter, Blackley, out of which it is

intended that the district recommended in such scheme to be constituted shall be taken, and such incumbents and such patrons have respectively signified their assents to the same scheme.

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, and of the Act of the sixth and seventh years of Her Majesty, chapter thirty seven, duly prepared and laid before Her Majesty in Council a scheme, bearing date the thirty-first day of May, in the year one thousand eight hundred and sixty-six, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter one hundred and thirteen, and of the Act of the sixth and seventh years of your Majesty, chapter thirty-seven, have prepared, and now humbly lay before your Majesty in Council, the following scheme for constituting a separate district, for spiritual purposes, out of the parish of Old Radnor, situate partly in the county of Radnor and partly in the county of Hereford, and wholly in the diocese of Hereford.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular part of the said parish of Old Radnor which is hereinafter mentioned and described (such part not at present containing within its limits any consecrated church or chapel in use for the purposes of Divine worship), should be constituted a separate district, for spiritual purposes, in the manner hereinafter set forth.

"And whereas a sum of three thousand pounds

"And whereas a sum of three thousand pounds sterling has been contributed and paid to our account at the Bank of England by Robert Baskerville Mynors, of Evancoyd, in the said county of Radnor, Esquire, in aid of the endowment of the district hereinafter recommended to be constituted, and of the maintenance of the minister thereof for the time being, and we have in respect thereof agreed with the said Robert Baskerville Mynors, and have undertaken to provide and pay, by equal half-yearly payments, on the first day of May and the first day of November in each and every year, to such minister as aforesaid, when he shall have been duly licensed in accordance with the provisions of the herein secondly-mentioned Act, and to his successors, the yearly sum of one hundred pounds.
