

LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF ACT BY HEBDEN
BRIDGE DISTRICT, YORKSHIRE (W.R.)

WHEREAS the Local Government Act, 1858, was duly adopted on the 12th day of May, 1866, by the district of Hebden Bridge, in the county of York, within the boundaries of that district, as settled for the purposes of the hereinbefore recited Act; and notice of such adoption has been duly given, as required by such Act; and it has now been certified to me that a copy of such notice has been duly advertized, and that copies have also been duly affixed in such district, and the period fixed by the said Act for appeal has now expired, and no such appeal has been made:

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State, do hereby give notice, that the Local Government Act, 1858, has been adopted within the said district of Hebden Bridge; and that such Act will, at the expiration of two months from the date of the passing of the aforesaid resolution, have the force of law within such district.

LOCAL GOVERNMENT ACT, 1858.

ADOPTION OF ACT BY SUTTON-IN-ASHFIELD,
NOTTINGHAMSHIRE.

WHEREAS a Resolution for the adoption of the Local Government Act, 1858, was, on the 13th day of December, 1865, passed by the parish of Sutton-in-Ashfield, in the county of Nottingham; and notice thereof, in writing, was given to me, as one of Her Majesty's Principal Secretaries of State, as required by such Act, and appeal has been duly made to me against the validity of the votes given on the subject of the adoption of the said Act; and inquiry has been directed into the matters therein alleged, and report made to me thereon:

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State as aforesaid, do hereby make order, with respect to the matters in question on such appeal, as follows, namely:—that the said vote for the adoption of the Local Government Act, 1858, passed by the said parish, was valid; and that the said Act do come into operation in such parish from and after the 9th day of July, 1866.

NOTICE is hereby given to all persons interested therein, that preparations are now being made for the intended distribution of the slave and tonnage bounties, awarded for three slave dhows, names unknown, captured on the 11th April, and 14th and 15th May, 1864, respectively, by Her Majesty's ship "Rapid."

Agents or other persons having any just and legal demand, unliquidated, against the said proceeds, are required to transmit the particulars of any such demand to the Registrar of the High

Court of Admiralty, in order that the same may be examined, taxed, and allowed by that officer, and paid under the sanction of the Judge of the said Court.

Agents and all other persons holding powers of attorney, prize orders, assignments, or other instruments, by virtue of which they may be legally entitled to claim the share belonging to any captor, are requested, with as little delay as possible, to transmit the same, accompanied by the usual documents, to the Prize Branch of the Department of the "Accountant-General of the Navy, Admiralty, Somerset-House."
